

In a letter to you dated May 3, 1973 (see attached copy), you were told that unless you made certain work corrections for the Boise-Humboldt Beautification Project by May 14, another contractor would be given this assignment.

You have failed to meet the May 14th deadline. Therefore, the Commission is terminating its contract with you. This termination is based on that provision of the contract entitled: General Conditions for Site Preparation - Part I, Section III. a. which reads as follows:

"HT. TERMINATION: DELAYS: AND LIQUIDATED DAMAGES

> Termination of Contract а.

If the Contractor refuses or fails to prosecute the work with such diligence as will insure its completion if t within the time specified in these Contract Documents, plus any extension thereof as provided in these Contract Documents, the Local Public Agency, by written notice to the Contractor may terminate the Contractor's right to proceed with the work. Upon such termination, the Local Public Agency may take over the work and prosecute the same to completion, by contract or otherwise, and the Contractor and his sureties shall be liable to the Local Public Agency for any additional cost incurred by the Local Public Agency in its completion of the work and they shall also be liable to the Local Public Agency for liquidated damages for any delay in the completion of the work as provided below. If the Contractor's right to proceed is terminated, the Local Public Agency may take possession of and utilize in completing the work such tools, materials, equipment and plant as may be on the site of the work and necessary therefor."

As authorized under Section III. a., the Commission intends to hire another contractor to complete the job corrections referred to above. The cost of such work will be subtracted from the amount of money which would have been owing to you had you complied with all the terms of the contract. The amount of money remaining, if any, will be sent to you within a reasonable amount of time after the work is completed.

Nothing in the above statement or in any action taken by the Commission concerning this matter is to be interpreted as a waiver of the Commission's rights under Section III. b., which reads as follows:

b. Liquidated Damages for Delays

If the work is not completed within the time stipulated in Section, TIME FOR COMPLETION under SPECIAL CONDITIONS, including any extensions of time for excusable delays as herein provided, or reductions in time due to omission of part of the work, the Contractor shall pay to the Local Public Agency as fixed, agreed, and liquidated damages (it being impossible to determine the actual damages occasioned by the delay) for each calendar day of delay, until the work is completed, the amount as set forth in Section, LIQUIDATED DAMAGES under SPECIAL CONDITIONS and the Contractor and his sureties shall be liable to the Local Public Agency for the amount thereof."
