

After living for twenty-five years under the threat of the boom, which has changed our lives from those who seek success and retirement, into a society of "live for today and the hell with tomorrow". So who is afraid of death in our country anymore, maybe the mature and the old, but not the youth. The new morality is the product of change brought about by the pill, the war and the atomic bomb. We can't forget the assassinations of Martin Luther King, Malcolm X and the Kennedy brothers, these men believed in changing our country from the destructive classes and socialist country that we live in and was destroyed by that same power. My first reason for pursuing education is to shorten the communication gap with the local, state, and national establishment.
