Without a doubt cooling and warming shelters are necessary when heat waves and inclement weather ensue. And, East Portland has a large population of low income and unhoused people. Because of this it seems always to be the case that the County and City turn to the East Portland Community Center (EPCC) in providing emergency shelter. This displaces many community members – including people with disabilities and mobility issues. people of modest means and seniors – from accessing the center and pool which many rely on for their mental health and physical wellbeing. In recent years, EPCC patrons have made much more than their fair share of sacrifices to rise to the occasion. With due respect Commissioner, Multnomah County and the City of Portland need to identify alternatives such as high schools and churches other community centers instead of always displacing the EPCC community. 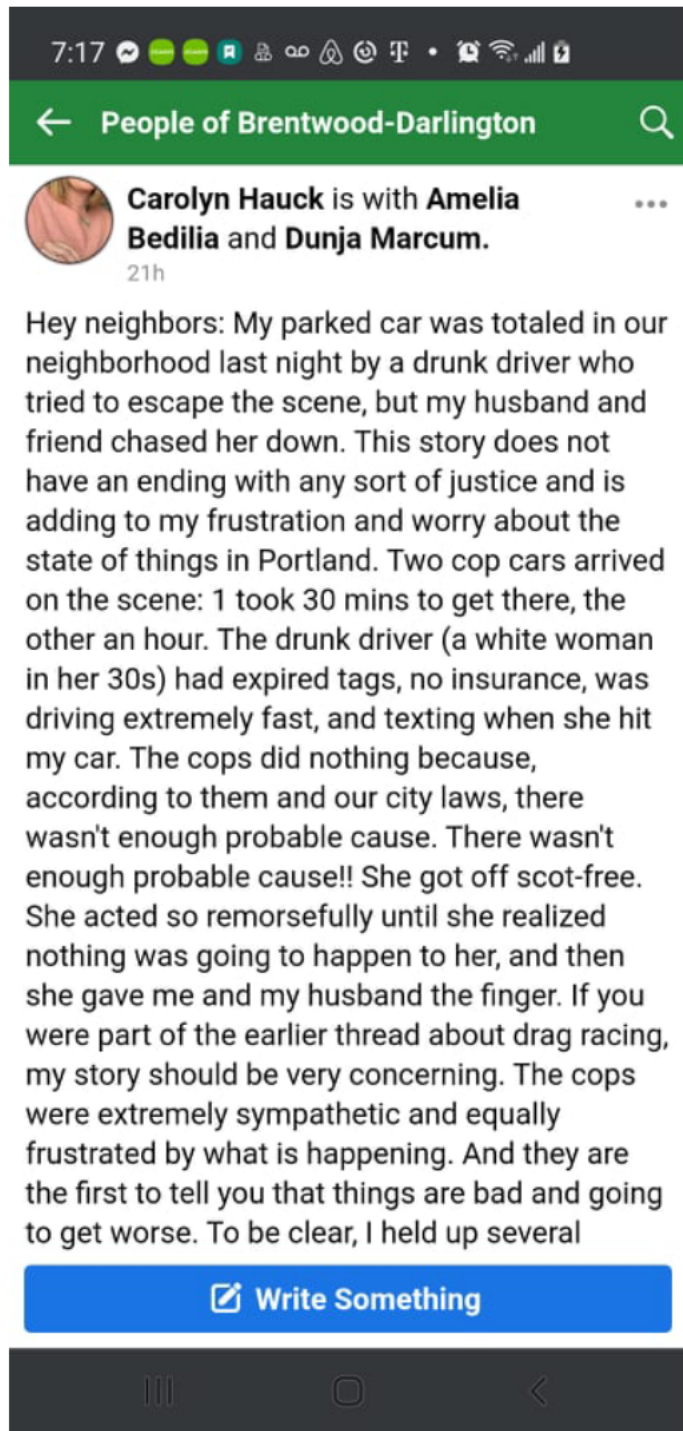

Portland Water Rates, Fiscal Year 2020-21

The average single family residential monthly bill for water service increased 6.5% on July 1, 2020. The monthly water bill for the typical single family residential customer using 5 ccf a month in fiscal year 2020-2021 is \$44.89. The city adjusts water rates annually on July 1.

With the volume rate \$5.593 per ccf = 1.3 gallons cost a penny.

Hello Ms. Rubio, I'm a resident in the Woodlawn neighborhood. I work for a federal public health agency serving Native Americans and my spouse works for Oregon Health Authority. I'm very concerned about the gun violence in the Woodlawn neighborhood. Hearing gunshots, day or night, has become the norm since last summer. A neighbor's home was hit with over 80 rounds in December and then over 20 in January. What's even more terrifying is that toddlers regularly play outside in their front yard. We've had multiple young men killed by gun violence in our neighborhood within the last 8 months. Most recently a 14 year old boy was killed. I understand that gun violence is a complicated topic but we're in urgent need of policy changes to address this. I worry that my husband or I will get caught in crossfire walking our dogs but I'm mostly concerned about the children of Woodlawn. Just hearing gunshots on the regular is traumatizing. Kids have a right to feel safe and parents/grandparents/guardians shouldn't need to worry if their child will be shot while playing outside. Thank you for taking the time to read my concern.
