This morning I was so proud to be at the Portland City Council meeting listening to the testimony by three representatives of the newly established Portland Nonprofit Arts Coalition. This was the culmination of many months of planning and strategizing with Mark McCrary, the Executive Director of the Portland Gay Men's Chorus.

Four months ago Mark and I had a very frustrating production meeting with Portland's Center for the Arts staff where they let us know about new exorbitant unexpected fees for an upcoming PGMC concert despite the fact that we had signed a contract one year earlier. It became apparent that one group alone would not have enough influence to address rising costs, transparency, and the multitude of other issues facing nonprofit groups that struggle to perform at our city owned venues. Most folks in Portland are not aware that the high costs at these venues are becoming unsustainable for almost every local performing group, and with no other venue options, the future is extremely uncertain and bleak for many, and something has to change.

The idea was formulated to create a Coalition of small to mid-sized performing arts groups that perform, or want to perform, at P5 venues, in order to have a louder and more impactful voice. Mark and I met with Commissioner Carmen Rubio who provided great insight and support, and shortly after the meeting we began contacting other nonprofit groups to join this new Coalition.

Mark has done an outstanding job facilitating our efforts, and we shortly had 15 groups that enthusiastically jumped on board. After several meetings and planning sessions, today Mark, Graham from White Bird and Jenn from Oregon Children's Theatre presented thoughtful and engaging testimony to

bring our collective issues to light. This is only the first of many steps to implement change, but it was very encouraging to hear the positive feedback from the Commissioners and have the opportunity to speak with their staff afterwards. This is not a quick fix, but is a first step in the right direction.

The City recently passed Our Creative Future - [www.ourcreativefuture.org](http://www.ourcreativefuture.org) - and today Coalition members were invited to be a part of the upcoming discussions that will outline actionable steps to realize the vision and implement many of the goals to center equity, accessibility, and costs of Portland venues.
