1. On Monday I did a bridge tour with Multnomah County Chair Jessica Vega Pederson and Tri-Met executive director Sam Desue. We toured the Burnside and Hawthorne Bridges. It is easy to take these bridges for granted, but they are incredibly complicated machines. Thank you to the staff that work on and operate them.

2. On Wednesday, we heard about their investment plan from Portland Clean Energy Fund. PCEF has been a work in progress, but I am grateful for the staff and Commissioner Carmen Rubio's work. These investments will focus on renewable energy, transportation decarbonization, green infrastructure, jobs, agriculture, etc.

3. On Thursday morning, I attended the Joint Policy Advisory Committee on Transportation. This meeting shapes regional priorities on transportation investments. This meeting focused on earthquake readiness for the Burnside Bridge project.

4. On Thursday evening, we heard about the Police Accountability Committee report. A lot is going on in this 365-page report, and I look forward to having a robust and thoughtful debate about the program and its recommendations.

5. We have a City-County Joint Office of Homeless Services Work Session this evening. A consultant recently investigated weaknesses and opportunities for the JOHS, and this is our chance to discuss them.

Yesterday, we joined Catholic Charities of Oregon to celebrate the groundbreaking of Francis + Clare Place, a new 61-unit Permanent Supportive Housing complex in the inner SE neighborhood of Buckman designed to serve individuals exiting homelessness.

PSH residents typically live with disabling conditions and have little to no income. With Joint Office of Homeless Services funds, Catholic Charities will provide case management and resident services, while Native American Rehabilitation Association of the Northwest, Inc. (NARA) will contribute culturally specific services for these vulnerable Portlanders.

"With housing they can afford, and the support of this community," said Commissioner Carmen Rubio "with amenities, green space, and transportation nearby, the residents of Francis + Clare Place will gain the stability, skills, and independence they need to thrive."

Francis + Clare Place was made possible by funding from the voter-approved Portland Housing Bond. 14 out of 15 Bond projects are now open or under construction, and the Bond is exceeding all major goals. Over 4000 Portlanders in need will be able to live in Bond-funded homes.

Now, I'm okay with something like that just as long as it's NOT IN A RESIDENTIAL NEIGHBORHOOD like mine.

Not only is it dangerous for the residents that lawfully live here, but it deteriorates the neighborhood drastically.

We're not talking about housing mothers and children, or people in recovery.... We are talking about housing ACTIVE DRUG ADDICTS who are getting obliterated in public, committing crimes, and being a nuisance.

I'm a disabled 46 year old disabled  
woman who lives in a condo next to  
the Steel Bridge on NW Naito Parkway  
in downtown Portland Old Town/

On my way to MAX red/ blue line train  
today  
( July 20, 2023 ) a man living in the  
camp next to the old town Chinatown  
MAX stop threatened me with a large  
hunting knife as a woman came after  
me threatening physical assault.

I called 911, reported the incident,  
and the man was arrested for an  
outstanding warrant, but the woman is  
still there.  
( July 20, 2023 police report  
23190339 )

These are only two of the people who  
regularly harass people trying to  
access public transportation through  
this route daily.

My sole form of transportation is the  
MAX, and buses due to my disability  
making it unable for me to drive.

Me, and others, can not safely access  
the public transportation in our area  
due to the city's large illegal  
unsanctioned camp that covers a  
square block starting at 1st and  
Flanders down to almost Davis street.

We have been requesting at this camp  
be dismantled for over 2 and 1/2  
years.

The city has played games between  
who's responsibility it is to sweep  
this area.

In the meantime it has left residence  
in our neighborhood vulnerable to  
violent crimes.

I witnessed a woman get sexually assaulted in this camp, trafficking, drug dealing, and an abundance of open use of illicit drugs.

A man from this same camp severely beat an elderly couple, and broke the wife's nose.

Numerous women have reported men harassing and following them home from this MAX station when walking through this illegal camp.

The whole block in this area is covered with trash, stripped bikes, and other property that is suspiciously like stolen property.

Large clouds of fentanyl smoke from this camp fill the north bound MAX platform poisoning people waiting for the train.

There are currently no working street lights in a large portion of this illegal unsanctioned camp, but when neighbors reported the problem with the lights to the city we were told the lights could not be fixed due to the large illegal unsanctioned camp.

This has added to the safety issues for residents caused by this unlawful camp just yards from our home.

I have sent numerous emails, testimonials, and reports to the city, but nothing has been done to remove this extremely dangerous illegal unsanctioned camp.

These incidents have affected my disability in a major way, and have had drastically affected my quality of life.

The city set a no camping ban for public areas like this recently, but has refused to abide by it leaving residents, like myself, in fear of taking public transportation in our neighborhood.

We are begging for the city to act now in order to ensure that residents have safe access to the public transportation, and Tom McCall Waterfront Park.

Attached to this email are links to videos of the current situation we are dealing with, plus my testimony pleading with city leaders to act before anyone else is hurt, or worse.
