Scott-Arleta Neighborhood Association Chair Matchu Williams held a walking tour and press conference to discuss the results of the first 3 months of a multi-bureau, collaborative pilot project aiming to reduce gun violence and related vehicle speeding in the area. The current pilot evaluation ranges 3 months from October – December of 2021.

"Mt. Scott-Arleta is a diversifying neighborhood including many households with young children that enjoy walking to Mt. Scott Community Center," said Mt. Scott-Arleta Neighborhood Association Chair Matchu Williams. "The sudden rise in gunfire and reckless driving last year shook the community and spurred on calls for safe streets where neighbors can gather together. The pilot project gives us hope for future investments into safe streets in Mt. Scott-Arleta and citywide."

Working with neighbors to implement their idea, the Portland Bureau of Transportation installed a total of 18 temporary, low-cost traffic barrels within a 6x6 block radius where the combination of gun violence and related speeding were most prominent.

"My office got involved in this neighborhood after a group of community members reached out to my office with an idea in response to the rapid uptick in violence in the area," said Commissioner Hardesty. "Neighbors were observing high-speed traffic from gun violence incidents in the area, further endangering community members beyond shots fired to threats of traffic violence as vehicles sped through slip lanes and nearby residential streets. I directed my staff and PBOT to collaborate with the local community

as well as bureaus across the city to pilot a holistic violence mitigation effort."

Commissioner Hardesty's office and PBOT were not alone, as the intervention became a collaborative effort involving PBOT, Parks & Recreation, OMF Division of Community Safety, Portland Police Bureau, and local community residents.

"To put an end to this rise in gun violence, we will need a combination of short-term mitigation and long-term solutions that address the root causes of violence. We need an all-hands-on deck, holistic response." said Commissioner Hardesty.

In 2020, Multnomah County Office of Sustainability and the City of Portland Bureau of Emergency Management(link is external) commissioned a study of the Critical Energy Infrastructure Hub in Northwest Portland. The study is intended to characterize and quantify the anticipated damages from the CEI Hub in the event of the Cascadia Subduction Zone (CSZ) Earthquake.

The study findings reinforce the public concerns about the facilities in the hub.Critical Energy Infrastructure Hub Tank Farm

- 1) The study estimated that a CSZ earthquake would result in total potential releases from the materials stored in tanks at the CEI Hub range from 94.6 million to 193.7 million gallons. This is equivalent to the size of the spill at the BP Deepwater Horizon oil spill disaster in the Gulf of Mexico that was the country's largest oil spill to date.
- 2) The study found that of the tanks for which year-built data was available the average tank was built in 1954, well before modern seismic standards had been established.
- 3) The monetized costs could range up to \$2.6 billion and based on prior spills, total costs and damages would likely be many multiples of the monetized amount.

Oil releases from the tanks to the river would spread downstream all the way to the Mouth of the Columbia River.
