# WHAT IS THE CHARTER COMMISSION?

Once in a decade, the City Council appoints 20 Portlanders to the Charter Commission to review the Charter and recommend amendments.

The Charter Commission is an independent body. It determines its own scope of work. The City Council may request that the Charter Commission review specific sections of the Charter, but ultimately it is up to the Commission to decide what to address. In the past, charter review has considered larger questions of policy as well as operational issues embedded in the Charter.
