As Portland-area Legislators, we'd like to express our strong support for full funding of the Portland Streets Response pilot project. Throughout the COVID-19 global pandemic, Oregonians have demanded change when it comes to policing and approaching systemic inequities. Historically, our cities and local governments have tended to criminalize poverty, mental health issues, and homelessness by arresting people who at times need dire human services. This lack of alternative public safety approaches result in millions of dollars spent on excess policing, an increase of costly ambulance rides, and an overall increase of avoidable emergency room visits.
