

ORDINANCE No.

An Ordinance creating a position in a new class of Model Cities Office Manager in lieu of a position of Clerk for the Model Cities Administration, fixing the rate of pay, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that the Model Cities Acting Director has recommended creating a position of Model Cities Office Manager in lieu of a position of Clerk to be responsible for general operation and appearance of the entire general office of the Model Cities Administration; that this position would establish a new classification; that the recommendation has been approved by the Mayor as Commissioner in charge; and that the position should be created as recommended; now, therefore, a position of Model Cities Office Manager is hereby created in the Model Cities Fund appropriation Model Cities Administration (6683.111) in lieu of a position of Clerk. The salary for the new classification of this position is hereby established in the current Compensation Plan at salary range No. 42 with entry level at step A.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that there may be no unnecessary delay in creating a position of Model Cities Office Manager as provided in Section 1 of this ordinance; therefore, an emergency is hereby declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
