

## ORDINANCE No. 134429

An Ordinance authorizing and directing C. Watts Yancey, Model Cities staff member, to confer with regional offices of federal agencies in Seattle, Washington, April 27-28, 1972, authorizing a warrant for \$42, providing for an accounting, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that the Commissioner in charge of the Model Cities Program has recommended sending C. Watts Yancey, Model Cities staff member, to confer with regional offices of federal agencies in Seattle, Washington, April 27-28, 1972; and that it would be in the best interest of the City of Portland to provide for his attendance; now, therefore, C. Watts Yancey is hereby authorized and directed to confer with regional offices of federal agencies in Seattle, Washington, April 27-28, 1972. The Mayor and the Auditor are hereby authorized to draw a warrant for \$42 in favor of C. Watts Yancey as an advance for expenses. Said warrant shall be charged to the Model Cities Fund appropriation Model Cities Administration, Travel and Transportation (6681.310). C. Watts Yancey shall file with the Auditor an accounting of actual expenses together with available receipts, and any remaining balance shall be deposited with the Treasurer and credited to the above appropriation.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that C. Watts Yancey may make arrangements without delay to travel to Seattle, Washington, April 27-28, 1972, as authorized in Section 1 of this ordinance; therefore, an emergency is hereby declared to exist, and this ordinance shall be in force and effect from and after its passage by the Council.
