

## ORDINANCE No. 134780

An Ordinance authorizing and directing Andrew Raubeson, Deputy Director of Model Cities, to attend an Advanced Workshop in Employee Development in Seattle, Washington, June 27-29, 1972, authorizing a warrant for \$43, providing for an accounting, and declaring an emergency.


The City of Portland ordains:

Section 1. The Council finds that the U. S. Civil Service Commission, Seattle Regional Training Center will conduct an Advanced Workshop in Employee Development in Seattle, Washington, June 27-29, 1972; that the Commissioner in charge of the Model Cities Program has recommended sending Andrew Raubeson, Deputy Director, to the workshop; and that it would be in the best interest of the City of Portland to provide for his attendance; now, therefore, Andrew Raubeson is hereby authorized and directed to attend the Advanced Workshop in Employee Development in Seattle, Washington, June 27-29, 1972. The Mayor and the Auditor are hereby authorized to draw a warrant for \$43 in favor of Andrew Raubeson as an advance for expenses. Said warrant shall be charged to the Model Cities Fund appropriation Model Cities Administration, Travel and Transportation (6681.310). Andrew Raubeson shall file with the Auditor an accounting of actual expenses together with available receipts, and any remaining balance shall be deposited with the City Treasurer and credited to the above appropriation.


Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that Andrew Raubeson may make arrangements without delay to attend the workshop in Seattle, Washington, June 27-29, 1972, as authorized in Section 1 of this ordinance; therefore, an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
