## ORDINANCE No. 132348

An Ordinance ratifying the action of the Commissioner of Finance and Administration in sending Josiah Nunn, Chairman, Citizens Planning Board for Model Cities, to a session on "Special Revenue Sharing Legislation for Elementary and Secondary Education" in Seattle, Washington, March 8, 1971, authorizing a warrant for \$47, providing for an accounting, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that a session on "Special Revenue Sharing Legislation for Elementary and Secondary Education" was held in Seattle, Washington, March 8, 1971; that the Mayor as Commissioner in charge of Model Cities directed Josiah Nunn, Chairman of the Citizens Planning Board, to attend the session; and that the action of the Commissioner should be ratified; now, therefore, the action of the Commissioner of Finance and Administration in sending Josiah Nunn to Seattle, Washington, March 8, 1971, is hereby ratified and approved. The Mayor and the Auditor are hereby authorized to draw a warrant for \$47 in favor of Josiah Nunn for actual expenses incurred. Said warrant shall be charged to the Model Cities Fund appropriation Citizens Participation, Travel and Transportation (6682.310). Josiah Nunn shall file with the Auditor an accounting of actual expenses together with available receipts.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that there may be no unnecessary delay in ratifying the action of the Commissioner of Finance and Administration in sending Josiah Nunn to Seattle, Washington, March 8, 1971; therefore, an emergency is hereby declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
