Climate Investment Plan development process



What is the Portland Clean Energy Fund?

- Generates **~\$100 million** annually to invest in efforts to address climate change and advance racial and social justice.
- Ballot measure passed by more than 65%
 of Portlanders in November 2018 and
 first climate fund measure created and led
 by communities of color in the US.

- 1% gross receipts surcharge on Portland sales by corporations with \$1B+ sales nationally and \$500k+ in Portland.
- Over \$145 million in grants awarded todate.

Climate Investment Plan: Portland's commitment to climate justice

- **Five-year road map** to fund community-led clean energy projects and climate solutions.
- Grounded in climate research and community engagement with multiple rounds of input.
- Uses an equity framework for all programs, which considers benefits to frontline communities, implementation feasibility, greenhouse gas (GHG) emissions reductions, and accountability.



- Improves the preliminary draft released March 14, 2023 based on >500 public comments.
- Uses information collected from workshops, surveys, 23 subjectmatter roundtable meetings, community studies, research, and best practices
- Leverages program history and experience to-date

Advancing climate justice through the CIP

Climate jobs, workforce, and contractor development

- 1,000 low-income and youth of color exposed to climate careers
- 700-900 trained workers in climate jobs
- 75-125 contractors expanding into sustainable sectors

Renewable energy and energy efficiency

- Clean energy improvements in 2,600 unregulated multifamily units, 3,250 singlefamily homes, 65 small commercial buildings
- Rent stabilized in participating multifamily units for 3 to 9 years

Transportation decarbonization

- 6,000 e-bikes distributed to income-qualified households
- 15,000-20,000 transportation wallets with distributed to income-qualified households



Advancing climate justice through the CIP (2)

Green infrastructure

- 800 2,000 low-income households receiving critical tree pruning services
- 15,000 25,000 more trees on public and private property

Regenerative agriculture

40,000 square feet land dedicated for regenerative urban farming


Organization capacity building

16-20 nonprofits with increased capacity to advance climate justice



Funding categories and allocations

From 2023 to 2028, PCEF will distribute an estimated **\$750 million** across **7 funding categories**:



- Enhanced clarity and comprehensiveness by including footnotes on additional program design details, alignment with Climate Emergency Workplan





Summary of changes to Climate Investment Plan full draft

General

- Added an executive summary to increase content accessibility
- Added expected carbon emissions reduction or sequestered
- Added and updated goal measures for strategic programs, and clarified distinction between outcomes and measures
- Added a visual diagram on the CIP development process
- Added clarity on the importance and role of community partnerships and workforce and contractor equity
- · Added workforce and contractor equity goals
- Emphasized accountability as a key aspect of the plan with details on the approach
- Demonstrated alignment of actions in the CIP with the Climate Emergency Workplan
- Safety on jobsites addressed in "Program-wide contractor and workforce equity approach and goals" section
- Footnotes included to offer additional details on program design choices and/or



Highlights of program-specific changes

Clean energy:

- Added expected number of units, homes, buildings served
- Clarified construction budget for life, health, safety, accessibility, or enabling repairs

Transportation decarbonization:

- Added information on prioritizing youth and increasing access for those with disabilities
- Clarified program roles for e-bike program
- Clarified next steps and scope of the workgroup

Access to fair and flexible capital:

• Built out new strategic program (SP13: Targeted electric vehicle financing tools)



Highlights of program-specific changes (continued)

Green infrastructure:

- Revised name to "Tree Canopy" maintenance reserve to reflect purpose of funding
- Additional \$2.2 million allocated as part of SP11: 82nd Ave climate infrastructure and community resilience grant program

Regenerative agriculture

- Allocation for grants reduced by \$1M
- Allocation for SP9: Increasing urban farming opportunities planning and land acquisition increased by \$2M

Workforce and contractor development

Added diverse contractor and workforce utilization goals (Appendix 1)
