In response to your September 5 letter, we must inform you that an exception to bureau policy against temporary fourway stops for experimental purposes cannot be made.

We therefore advise that you poll all residents: On both sides of N. Wall Avenue, from N. Yale to N. Depauw Sts.; On both sides of N. Monteith Avenue, same limits; On both sides of N. McKenna Avenue, same limits; On both sides of N. Westanna Avenu, same limits; On both sides of N. Princeton St, from N. Monteith to N. Westanna Aves.; On both sides of N. Yale St., same limits; On both sides of N. Amherst St., same limits; On both sides of N. Depauw St., same limits; On both sides of N. Depauw St., same limits; On both sides of N. Syracuse St., from N. Monteith to N. Wall Aves.

If 60% of these residents are in favor, a permanent four-way stop will be installed.

Dear Mr. Bergstrom:

At a recent meeting held by North Portland Citizens Committee, Inc. concerning the traffic situation on North Wall Avenue between Lombard and Willamette Blvd., those in attendance requested that a temporary four way stop be placed at Princeton and Wall and that studies be done to determine if a four way stop would decrease both volume and speed on the street.

The participants at the meeting were informed that the City of Portland's policy on stop signs doesn't include this type of feasibility study and that an exception would have to be obtained before the project could be undertaken. NPCC is therefore requesting that a thirty or sixty day study, whichever is felt to be sufficient, be undertaken and that temporary stop signs be placed at Princeton and Wall and studies done on traffic volume, rate of speed, noise impacts and accident rates be done when the signs are up so that comparisons may be made to the recent studies.

NPCC realizes that this request is unusual but we feel that the added information will help the residents of the area determine a course of action.

Dear Mr. Bergstrom:

I have reviewed the proposed Stop Sign warrants which you circulated in January, together with the present placement of stop signs within the neighborhood. While the proposed warrants clearly articulate some uniform standards, they do not seem to meet the needs of the Northwest District.

Northwest Portland is the city's most densely populated residential neighborhood. This concentration of people means that there is a heavy volume of pedestrian traffic. Approximately half of the residents do not own cars. Northwest also houses the highest percentage of elderly in the state. The safety of pedestrians is one of our major concerns.

Many buildings in Northwest Portland were constructed close to lot lines. This type of construction on corner lots reduces visibility at intersections. These buildings also preceded parking requirements, and on-street parking is heavily utilized by residents, employees and customers. Parked cars also tend to reduce visibility.

The mixture of commercial, residential, institutional and industrial usage in Northwest Portland generates a lot of traffic, particularly during rush hours. Stop signs are an

important aid in slowing the traffic, which increases the safety of pedestrians and of vehicles entering or leaving the streets. They also serve to route heavy traffic flow away from local service streets.

The standards set forth in the proposed warrants do not really speak to these important issues. Many of the accidents which occur in Northwest Portland are not reported because the cars involved are travelling at low speeds and the property damage is considered minor. The conditions which lead to these unreported accidents are just as dangerous to pedestrians and vehicles as those that result in reported accidents.

Any warrants which are submitted to the City Council should reflect the fact that Portland contains diverse neighborhoods, and that the traffic problems of these neighborhoods are not always susceptible to uniform solutions.
