PSR and its staff are worth every penny and more. They should be fully funded, be fully staffed and providing their much needed services citywide, 24/7. We have emergency services for crimes, physical health, fires but the types of emergencies these folks face often are not well managed, if at all. Or they are mismanaged, like going to the ER, a costly option when PSR is much more appropriate and more cost effective. I encourage support of PSR being able to support the folks they serve with supplies as it is a vital way of developing relationships and trust. For this reason, PSR should also never be asked to be part of law enforcement or sweeps. Their role is as an ally to this community and they should not be put in an antagonistic position. I am writing in support of the expansion of Portland Street Response (PSR) as a co-equal branch of the first responders, and expansion, as staffing allows, to a 24/7 program. The evaluations of PSR have shown that their response to mental health and behavioral crisis are a more appropriate response for the individuals in crisis, and reduce police response to 911 calls. This allows the police to respond to criminal issues.

Recently, the tasks that Portland Street Response can undertake have expanded, including transporting clients to services, and responding in public buildings. There may be additional services that could be evaluated, such as welfare checks (with specific criteria) and responding within private residences with occupant permission.

I recognize that the City of Portland has a budget deficit. However, studies have shown that PSR-type responses are 4x less expensive than a police response. Thus, I urge the mayor and the council to consider reducing police overtime as a funding source for expansion of Portland Street Response.

Thank you for consideration of expansion of Portland Street Response to become a co-equal and separate partner of first responders in Portland. As far back as May 2022, the previous City Council voted to expand PSR to 24/7. The time has come.....

My testimony is to question the resolution terms proposed by Mr. Kanal, and to support the expansion of Portland Street Response (PSR) Services which Mayor Wilson and the public safety unions worked on conscientiously in accordance with the public's desire and the needed professional expertise. I would like to take the opportunity to thank PSR labor, labor representation and leadership for enduring a morally corrupt climate where they have been used as pawns for the past 5 years, while trying to do a very difficult job, and being denigrated or spoken for, by people who have never in their life served a person in crisis.

Given the supposed enormous municipal deficit, which still allowed for 20+ million in renovations of city hall, the multiplication by 3 of large council employee salaries, the upcoming 15 million bill per FY for the police oversight board, while threatening essential services for the people footing the bill, I truly wonder where the budget stream is coming from while requesting those added line items in this new resolution. I guess public oversight having been eliminated through the dismantling of Budget Advisory Committees, we will never know, and the new opaque council fiscal practices are well and alive.

Medicaid reimbursement has been a lingering issue for over a year, and during Mr. Kanal's latest townhall in conjunction with Commissioner SIngleton, she brought up the fact that medicaid billing is being worked on for PSR services, essentially using the county as its billing hub for municipal services. This conversation has to be made very public: to benefit from medicaid reimbursements, PSR has to demonstrate 24/7 services. That demonstration has to come with a budget stream, which will be municipal (apparently?) even though there is no cost explicitly attached to Mr. Kanal's proposal? Makes no sense.

Portland taxpayers deserve clear, direct answers to the following:

Testimony from Hilary Nichols – In Support of Portland Street Response

Good afternoon Chair Novick, Chair Kanal, and members of the Community and Public Safety Committee,

My name is Hilary Nichols. I'm a resident of District 3 and, more importantly, a deep lover of everyone who lives in our Portland community.

I work as a community organizer at a community health center in Southeast Portland, where I connect daily with patients and neighbors about the social pressures that impact their health. Good afternoon, Councilors,

My name is Brian Owendoff. I live and work in District 4, and I appreciate the opportunity to address Councilor Kanal's proposal regarding changes to Portland Street Response (PSR).

To begin: what does it mean for PSR to become a "co-equal branch"? Are PSR team members going to undergo the same rigorous background checks, training, and continuing education requirements as Portland Police Officers? That phrase needs clear definition.

My understanding is PPB received few calls to 911 for responses that PSR now handle. Going to a 24/7 model is an added cost. Why does Commissioner Kanal's proposal state "no financial impact"? These costs were never a part of the PPB budget.

This proposal comes at a time when we are facing a constrained city budget, a large deficit, and threats to essential services. All public safety bureaus have requested to *maintain* current staffing and funding levels—so why are we proposing changes that seem to imply *increased* funding or expansion?

Furthermore, we need to talk about funding—specifically, Medicaid reimbursement. This has been a lingering issue for over a year. If PSR is to continue and grow responsibly, the City must have a transparent and public conversation about billing Medicaid through the County.

Portland taxpayers deserve clear, direct answers to the following:

- 1. How much will these proposed changes to PSR cost?
- 2. What tangible benefits will they bring to stakeholders?
- 3. Do PSR staff and leadership actually support this direction to 24/7 operation?
- 4. What legal liabilities would fall on the civilian committee proposed to lead PSR, especially if they go beyond recommendations and into decision-making?
- 5. Will the City's unions need to reopen bargaining agreements if these structural changes take place?
- 6. Lastly, while PSR helps manage certain calls more efficiently, it does *not* eliminate the need for police. We cannot responsibly reduce the

police budget and expect that to translate into faster or more effective 911 response times.

Looking at the bigger picture, the City should explore whether the County is better equipped to manage PSR under the umbrella of *Project Respond*. This approach would offer:

- A dedicated 24/7 crisis line
- Integrated access to Cascadia Health Services
- Eligibility for Medicaid reimbursement
- Transport capacity and insurance—functions currently managed by the County, and which PSR does not fully possess

Duplicating these services at the City level is not an efficient or effective use of limited taxpayer dollars. This proposal is playing "small ball" when a reassessment of overall spending between county and city is needed. The real solution is getting the unsheltered off the streets.

Portland residents—housed and unhoused alike—deserve a system that works, is financially responsible, and is built on clear governance and accountability.

Our team has seen all kinds of suffering up close, and it's clear to us that the appropriate response to a person's mental health crisis is an independent, unarmed alternative to police.

When PSR was being created, houseless Portlanders weighed in on what they believed would be the most appropriate response, (we helped ensure their voices were heard, distributing surveys at the library shift, and letting people know about a number of town hall-style events to solicit their suggestions). They helped shape the program and we owe it to them to keep it going as the vital, life-saving resource it's intended to be.

Portland Street Response should not be attached to any enforcement activities like sweeps, enforcing camping bans or forced engagement in services. Its workers should have access to life-saving supplies like naloxone, food, clothing and more in line with best practices in de-escalation.
