

## ORDINANCE NO. 176154

\*Accept a grant from Department of the Treasury, Bureau of Alcohol, Tobacco and Firearms, for Gang Resistance Education and Training by the Portland Police Bureau (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Department of Treasury, Bureau of Alcohol, Tobacco and Firearms is providing funds for the Gang Resistance Education and Training (G.R.E.A.T.) Northwest Region Training Program. This program educates youth about the dangers associated with joining street gangs and violent crimes.
2. The Portland Police Bureau will continue to be responsible for administering the G.R.E.A.T. Officer Training Program in the northwest region. The G.R.E.A.T. Program trains officers to provide instruction to grade-school-aged children in gang prevention and anti-violence techniques.
3. The City of Portland has been awarded \$220,000 for reimbursement of salaries for GREAT program staff, overtime, out of town travel, vehicles, miscellaneous supplies and services related to the grant purpose.
4. The grant agreement is for the period December 1, 2001 through November 30, 2002.
5. No match is required. Indirect is not allowed.

NOW, therefore, the Council directs:

- a. The Mayor is authorized to execute the cooperative agreement between the Department of Treasury, Bureau of Alcohol, Tobacco and Firearms and the Portland Police Bureau ATC020002.
- b. An increase in appropriation for FY 01-02 and transfer of funds for the grant award is authorized as follows:
