## ORDINANCE No.

\*Pay claim of Ronnie Gilbert. (Ordinance)

The City of Portland ordains:

#### Section 1. The Council finds:

- 1. Ronnie Gilbert, a minor, through his attorney, has filed a bodily injury claim against the City for injuries sustained August 23, 1996, at Grant Pool.
- 2. The claim has been investigated by the Bureau of Risk Management. Investigation indicates there is risk the City may be found liable. Therefore, in order to avoid the risk of a large jury award, we feel it is prudent to settle the claim at this time.
- 3. The Bureau of Risk Management recommends the claim be settled for \$42,500, subject to the claimant providing the City with a release in a form to be approved by the City Attorney.

## NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver a warrant in the amount of \$42,500 made payable to Becky McKinney, guardian ad litem for Ronnie Gilbert, and Gregory Kafoury, attorney.
- b. The Bureau of Risk Management will execute a payment authorization in the amount set forth in sub-paragraph (a) above.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this claim; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
