*Pay claim of Lovena Nash. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Lovena Nash, through her attorney, has filed a bodily injury claim against the City for damages suffered in an automobile accident on July 16, 1998.
- 2. The claim has been investigated by the Bureau of Risk Management. Investigation indicates there is risk the City may be found liable. Therefore, in order to avoid the risk of a large jury award, we feel it is prudent to compromise the claim at this time.
- 3. The Bureau of Risk Management recommends the claim be settled for \$25,000, subject to the claimant providing the City with a release in a form to be approved by the City Attorney.

NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver a check in the amount of \$15,000 made payable to Lovena Nash and her attorney, Bartlett Cole, and another check for \$10,000 made payable to the Travelers Insurance Company.
- b. The Bureau of Risk Management will execute a payment authorization in the amount set forth in sub-paragraph (a) above.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this lawsuit; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
