ORDINANCE NO.

*Contract with City Center Parking to operate ~~four~~ Goose Hollow parking lots and one in NW Portland for \$47,858 and provide for payment. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. City Center Parking was the lowest responsible bidder to provide operations services for four (4) parking lots in Goose Hollow, and one (1) at NW 3rd & Flanders.
2. Award of a contract to said bidder for this service at a cost of \$47,858.40 is recommended by the Purchasing Agent and approved by the Commissioner in Charge.
3. Funds are available for this service in the Parking Facilities Fund.

NOW THEREFORE, the Council directs:

- a. The Commissioner of Public Utilities and the Auditor are authorized to execute a contract, to be approved by the City Attorney, with City Center Parking to provide operations services for a total amount of \$47,858.40.
- b. The Mayor and the Auditor are hereby authorized to draw and deliver warrants chargeable to the Parking Facilities Fund when demand is presented, approved by the proper authorities.

Section 2. The Council declares that an emergency exists because a delay in processing this contract may result in unnecessary additional expense to the City; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
