

**ORDINANCE NO. 167598**

**\*Pay claim of Maegan Peterson. (Ordinance)**

**The City of Portland ordains:**

**Section 1. the Council finds:**

1. Maegen Peterson, through her mother Elizabeth Peterson, and her attorney, John Stanley Sather, has made a claim for personal injuries, as a result of an accident at the Police Bureau's East Precinct weight room on June 18, 1991.
2. The lawsuit has been investigated by the Risk Management Division and also the City Attorney's Office, and it appears that there is a risk that the City would be found liable; and that it is prudent to settle the lawsuit in order to avoid full liability therefore and further costs of defense and litigation.
3. Risk Management recommends that the lawsuit be settled for \$25,000, subject to the plaintiff providing the City with a Release in a form to be approved by the City Attorney.

**NOW, THEREFORE, The Council directs:**

- a. The Mayor and Auditor are authorized to draw and deliver a warrant in the amount of \$25,000, made payable to Elizabeth Peterson, as Guardian Ad Litem for Maegan Peterson, and John Stanley Sather, Attorney at Law, as settlement in full of all claims for damages upon receipt of a Release approved by the City Attorney.
- b. Risk Management will execute payment authorization in the amount set forth in subparagraph (a) above.

**ORDINANCE No.**

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this lawsuit; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
