ORDINANCE NO.

\*Merchant services processing agreement with US Bank for credit card donations for Classical Chinese Garden project (Ordinance).

The City of Portland ordains:

Section 1. The Council finds:

1. The Council has authorized the City to enter into an agreement with the Classical Chinese Garden Society and the Classical Chinese Garden Trust in order to develop, raise funds for, construct and establish a classical Chinese Garden in the City of Portland.
2. Under that agreement, funds raised for the project will be held by the City in a trust fund for the Classical Chinese Garden project.
3. In order to facilitate the solicitation of donors, it is in the public interest to enable the City to accept donations for the project by credit card.
4. US Bank has agreed to provide merchant services to process Visa and MasterCard donations and to waive its fees for those services.

NOW, THEREFORE, the Council directs:

- a. The Mayor is authorized to execute on behalf of the City of Portland a Merchant Services Processing Application with US Bank, once approved as to form by the City Attorney, in order to allow the City to accept donations to the Classical Chinese Garden trust account by Visa and MasterCard.

Section 2. The Council declares that an emergency exists in order to avoid undue delay, and to allow the fundraising process to continue; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
