

ORDINANCE No. 158710

An Ordinance waiving the rental charges for use of the Civic Auditorium per City Code Section 20.16.010 on July 1-2, 1986, for the production of "Legends", presented by The Legends! Company, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Chapter 20.16.010 of the City Code states that effective July 1, 1986, the rental charge for use of the Civic Auditorium is \$2,200 for an evening performance and \$1,250 for a matinee performance.
2. Celebrity Attractions, Inc., had contracted with the City to present the production of "Legends" at the Civic Auditorium from June 25, 1986, to July 2, 1986, but due to financial difficulties has had to cancel its presentation of the show.
3. Unless The Legends! Company can secure some partial rental relief, the Company will be forced to cancel the production.
4. In order to salvage the production, retain public faith and not create a further adverse impact on the entertainment market in Portland, it is important and prudent for the City to waive the rental charges for July 1-2, 1986.

NOW, THEREFORE, the Council directs:

- a. For the production of "Legends" at the Civic Auditorium from June 25, 1986, through July 2, 1986, and for that production only, the Manager of the Portland Center for the Performing Arts is authorized to waive the total rental charge of \$5,650 for the two evening performances and one matinee performance scheduled on July 1-2, 1986.

Section 2. The Council declares that an emergency exists because a decision is needed immediately so that a lease permit for use of the Civic Auditorium for this production can be properly executed and the show can go forward as scheduled; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
