

ORDINANCE No. 158717

An Ordinance authorizing the use of West Delta Golf Course for The Portland Junior Golf Championships on July 14 & 15, 1986 without payment of greensfees, notwithstanding provisions of Section 20.20.010 of the City Code, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Parks, in cooperation with private business, will inaugurate an annual junior golf tournament which will be limited to age 18 and younger. This tournament will be called The Portland Junior Golf Championships.
2. Through this Tournament the Park Bureau will provide a public service to the City's youth while at the same time promote the City's golf program.
3. The City of Portland will waive greensfees and private contribution will provide promotion and prizes.

Now, Therefore, the Council directs:

- a. Use of the West Delta Golf Course is authorized for The Portland Junior Golf Championships on July 14 & 15, 1986 without payment of greensfees, notwithstanding provisions of Section 20.20.010 of the City Code.

Section 2. The Council declares that an emergency exists because delay in enactment of this Ordinance would cause unnecessary difficulty in making arrangements for this Tournament; Therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
