

**ORDINANCE No. 158757**

An Ordinance amending Ordinance Nos. 158544, 158545, and 158570, passed by Council May 28, 1986, and June 4, 1986, in connection with the SW 4th Avenue, SW Maricara Street Sanitary Sewer Project, granted by Ronald B. Hankins and Rose Hankins, Paul Henry Thoma, and Daniel Friedman and Angeline M. Friedman, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Ordinance Nos. 158544, 158545, and 158570, passed by Council May 28, 1986, and June 4, 1986, accepted sewer easements granted by Ronald B. Hankins and Rose Hankins, Paul Henry Thoma, and Daniel Friedman and Angeline M. Friedman, and authorized payment therefor in connection with the SW 4th Avenue, SW Maricara Street Sanitary Sewer Project.
2. The construction fund name and BUC number were incorrectly stated in Section 1, Subsection "b" of Ordinance Nos. 158544, 158545, and 158570.

NOW, THEREFORE, the Council directs:

- a. The last two lines in Section 1, Subsection "b" of Ordinance Nos. 158544, 158545, and 158570 should be changed to read as follows:

said warrant to be charged to the LID Construction Fund BUC 74200231, Project No. 4137.

Section 2. The Council declares that an emergency exists because a delay in amending Ordinance Nos. 158544, 158545 and 158570 could result in improper billing and cause delays in paying the property owners; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
