ORDINANCE No. 158787

An Ordinance adjusting the 1986-87 approved budget for ordinances passed by Council between May 21 and June 25, 1986, transferring appropriation within the General Fund; creating ten positions and abolishing nine positions; establishing an effective date of July 1, 1986; and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Certain ordinances were adopted by the City Council between May 21 and June 25, 1986, which affect the 1986-87 budget.
- 2. The specific ordinances which affect the 1986-87 budget approved by Council are numbered as follows: 158524, 158608 and 158708.
- 3. Adjustments should be made to the 1986-87 budget to carry out the intent of these ordinances and actions.

NOW, THEREFORE, the Council directs:

- a. That appropriation be transferred within the General Fund in accordance with Exhibit I_{\bullet}
- b. That ten full-time positions are hereby created with salaries in accordance with the current Compensation Plan as shown in Exhibit II.
- c. That nine positions are hereby abolished in accordance with Exhibit III.
- Section 2. The effective date of these actions is hereby established as of July 1, 1986.
