ORDINANCE NO. 158890

An Ordinance amending Agreement No. 23219 between the City of Portland and the Burnside Community Council by increasing the agreement amount by \$8,200, transferring appropriations within the Housing and Community Development Fund in the amount of \$8,200, authorizing the drawing and delivery of warrants, providing for acceptance, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that:

1. There is a need to provide emergency shelter in Portland.
2. The Housing and Community Development Program is funding Baloney Joe's Shelter through Burnside Community Council, agreement No. 23219 from October 15, 1986 through March 1987.
3. This service benefits low income residents in the Downtown/ Burnside area and it is in the public interest.
4. There is a need to provide night shelter between August 15 and October 15 and to have Baloney Joe's open during the day.
5. In order to provide these expanded services, Agreement No. 23219 needs to be increased by \$8,200.
6. Appropriations in the amount of \$8,200 need to be transferred within the HCD Fund.

NOW, THEREFORE, the Council declares that:

- a. Contract No. 23219 between the City of Portland and Burnside Community Council is hereby amended by increasing that total amount by \$8,200.
- b. That the FY 86-87 City budget is amended as follows:

- c. The Mayor and Auditor are authorized to draw and deliver warrants for said contract from the Housing and Community Development Fund.

ORDINANCE No.

Section 2. This ordinance shall not become effective until the Contractor (Burnside Community Council) has filed with the City Auditor a document accepting the terms and conditions hereof which have been approved by the City Attorney.

Section 3. So that there will be no delay in implementing the provisions of this ordinance, the Council declares that an emergency exists and this ordinance shall be in force and effect from and after its passage by Council.
