Katz: Commissioner Francesconi is off on personal business. The rest will come in, I hope. Let's take communications. Why don't you have a seat.

Trish Trout: Good morning to mayor Katz, to the members of the city council. I have patricia trout, i'm president of the Portland state university alumni association. Richard Koenig: Good morning. City of Portland, good morning, city council. Good morning alumni. Don't take off yet. You can all relate to this.

Leonard: It starts.

Koenig: I'd like to share a cartoon of one of our prominent citizens. It apparently has been stopped -- could we have the overhead projector on this? He apparently has been stopped at this point, however what i'm bringing to council's attention is the -- "the Oregonian"'s interpretation here, rendition, of what we all think is funny, or what we can relate to and what is not funny, but because we can relate to it it invokes an emotional response, and therefore is cartoonable. We have an image of a citizen being followed by a public servant, who in former good times would all be glad to see in our rearview mirror, but everybody here now knows that the public servants who are driving around and cops like that give us cold, sweaty palms when they pull up behind us. That's not the way it was intended to be, folks. The city charter of Portland doesn't provide for the characterization of the public by their public servants. I've read it. I hope you folks will take the time to while you're still in office. I've got another -- i've got another picture here that i'd like to share. As a result of the -- is that going to come out? Any chance to focus it on -- get the whole thing? As a result of the activities petitioning for redress of grievance, trying to show the reality of the law and the violations of the law that are routine on the streets of Portland, it was guessed that I must have made threats against the mayor's life in september, recently, just because I have been calling for an observance of the law, or show me the law that says we get to be terrorized. One or the other, that's all i've been asking for. And as a result, i've got a -- a poster here, a Portland police bureau poster, and the bottom line -- see the bottom line in red? You can't reduce that? The bottom line indicates that my life is on the line here. Somebody got it on the cop's database that I might shoot them, or that I will shoot them, if contacted. That's a red flag. My life is worth less thanks to my petitioning in front of this body. And folks out there at home, if they'll do this to me, what are they doing to you?
