

RESOLUTION No **35411**

Accept American Planning Association and Oregon APA Awards to Strategies for Fair Housing (Resolution)

WHEREAS, In July 1992, a Task Force for Fair Housing Strategies was appointed by Commissioner Kafoury, and

WHEREAS, the charge to the Task Force was to identify issues related to siting essential special needs housing facilities in the City of Portland, to ensure full compliance with the Federal Fair Housing Act, and to suggest solutions that focus on mediation and mitigation of impacts, education and advocacy, and inclusion of neighbors, and

WHEREAS, the Task Force's recommendations resulted in Strategies for Fair Housing, a set of policies that reduces barriers to siting housing for people with special needs and integrates facilities throughout the community, utilizes mediation and education to involve the community in siting decisions, and recommends inclusionary zoning for special needs housing, and

WHEREAS, the City Council adopted the recommendations and made revisions to Title 33 to implement those recommendations as of January 94, and

WHEREAS, recommendations from the Task Force Report continue to be implemented in siting special needs housing, and

WHEREAS, the Oregon Chapter of the American Planning Association nominated the Strategies for Fair Housing for a 1995 National Planning Award, and


WHEREAS, Strategies for Fair Housing was selected from over 100 entries to receive APA's Outstanding Planning Award for Planning Implementation in a Large Jurisdiction, and

WHEREAS, the Oregon Chapter of the American Planning Association selected Strategies for Fair Housing to receive their 1995 Award for Excellence in Planning;

NOW THEREFORE BE IT RESOLVED that the City of Portland accepts these awards for the Strategies for Fair Housing and recognizes the work of the Task Force and staff that resulted in this outstanding national recognition
