WHEREAS, the City's Overflow Treatment Facility Siting Task Force of 1995 has recommended that specific community benefit opportunities, or amenities, at Swan Island and the River District be developed in association with a new overflow treatment facility which the Task Force recommends be built at each site;

NOW THEREFORE, BE IT RESOLVED that the City Council adopts guidelines, described in the attachment, to achieve multiple benefits in the pursuit and delivery of community benefit opportunities that may arise in the development of capital improvement projects under the City's combined sewer overflow program.

BE IT FURTHER RESOLVED that the guidelines described by this resolution and its attachment are subject to all other City requirements including bond covenants, statutes, ordinances and charter limitations governing the combined sewer overflow program and expenditures from City sewer funds, and are further subject to review and change by the City Council at any time.
