Request the Clackamas County Commission to transfer jurisdiction of county roads in the Garthwick Subdivision to the City of Portland (Resolution)

WHEREAS, the area known as the Garthwick Subdivision, which is located in Clackamas County, was annexed to the City of Portland on December 8, 1950, and

WHEREAS, the City of Portland has been providing maintenance of county roads in the Garthwick Subdivision since the area became part of the City of Portland, and

WHEREAS, transfer of road jurisdiction will give the City of Portland the authority to continue providing maintenance and other transportation services in the Garthwick Subdivision, and

WHEREAS, the City of Portland adopted an Urban Services Policy (Resolution 33327, February 23, 1983) which provides for the establishment of an Urban Services Boundary and establishes the City's role as the principal provider of municipal services within that Boundary,

NOW, THEREFORE, BE IT RESOLVED, that the Council of the City of Portland requests that the Clackamas County transfer jurisdiction of county roads in the Garthwick Subdivision as shown in Exhibit A to the City of Portland
