- 1 The City Council approves and adopts the City Engineer's plans, specifications and estimates for construction of street and storm sewer improvements in the SE 48th Avenue SE Mitchell Street to SE Raymond Street Local Improvement District, as filed with the City Auditor
- The City Council determines the character of the local street and storm sewer improvements as provided in the preliminary plans and specifications on file in the City Auditor's Office
- 3 The City Council determines the boundaries of the local improvement district that receives special and peculiar benefit from the proposed improvements as set forth in Exhibit A
- The City Council declares its purpose and intention to construct street and storm sewer improvements in the SE 48th Avenue SE Mitchell Street to SE Raymond Street Local Improvement District, in accordance with plans and specifications on file with the City Auditor
- The City Council shall assess property within the local improvement district as provided by Charter and City Code and based on the special and peculiar benefit received as a result of constructing the local improvements
- 6 The estimated cost of improving the local street and storm sewer is \$132,636 60 Final costs shall include contractors payments, advertising, progress payment interest, design and inspection engineering, superintendence and administration
- 7 The City's share of the local improvement is estimated to be \$30,569 84 The property owner share is estimated to be \$102,066 77
- The local street and storm sewer improvements will be started and completed on the dates contained in the "Special Specifications" of the construction contract
- The City Council directs the City Auditor to publish this resolution as provided in Charter and City Code. The City Auditor is further directed to notify property owners of the estimated costs of the street and storm sewer improvements, and of the hearing to consider formation of the local improvement district as provided in City Code.
