Authorize preparation and submission of a Plan of Advance Refunding for Sewer System Revenue Bonds (Resolution)

- WHEREAS, current interest rates in the capital markets have fallen to levels where it may be advantageous for the City of Portland to advance refund certain maturities of its outstanding Sewer System Revenue Bonds 1992 Series A and Sewer System Revenue Bonds 1994 Series A which are eligible to be refinanced, and
- WHEREAS, prior to issuing advance refunding bonds it is necessary to prepare and submit to the Oregon State Treasurer a Plan of Advance Refunding the facts, circumstances and plan pursuant to which the City of Portland would issue its advance refunding bonds, and
- WHEREAS, it is a high priority to achieve economic savings for benefit of the ratepayers of the City of Portland's sanitary sewer and stormwater drainage system whenever reasonable and economically feasible, and
- WHEREAS, the City Debt Manager and other staff within the Office of Finance and Administration have the experience and knowledge of the City's sewer system revenue bond financing program to prepare the required Plan of Advance Refunding,

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Portland directs the Office of Finance and Administration prepare a Plan of Advance Refunding, which plan shall demonstrate a three percent (3%) or better aggregate savings on a present value basis resulting from such advance refunding and, when deemed complete by the Debt Manager, cause such Plan of Advance Refunding to be submitted to the Oregon State Treasurer for approval
