Authorize the City Attorney to file an application to appear *amicus curiae* in *Outdoor Media Dimensions, Inc v State of Oregon*, CA A91779, SC S44590 (Resolution)

WHEREAS, the State of Oregon is in litigation with Outdoor Media Dimensions, Inc regarding the validity of statutes and administrative rules relating to regulation of signs along state highways, and

WHEREAS, the Oregon Supreme Court has accepted review of a Court of Appeals decision rejecting certain challenges to the state's sign regulations, including challenges based upon Article I, § 8 of the Oregon Constitution, and

WHEREAS, the constitutional claims raised in the State's litigation are relevant to the City's options for regulation of signs, and

WHEREAS, the City Attorney believes that participation by the City as an *amicus curiae* would assist the Oregon Supreme Court in fully considering the implications arising from various interpretations of Article I, § 8 of the Oregon Constitution,

NOW THEREFORE, BE IT RESOLVED that the City Attorney is authorized to apply to the Oregon Supreme Court for permission for the City of Portland to appear *amicus curiae* in the case of *Outdoor Media Dimensions, Inc v State of Oregon*, CA A91779, SC S44590
