That portion of SE Knight Street lying between the north line of Lots 1, 2, 3 and 4, Block 11, P J Martin's Tract and the south line of former Lots 7 and 8, Block 10, P J Martin's Tract (currently a portion of TL 50, Section 23, T1S, R1E) and Lots 2, 4 and 6, Block 1, Brown's Tract, in the City of Portland, County of Multnomah, State of Oregon

NOW THEREFORE, BE IT RESOLVED, that proceedings be and they are hereby initiated by the Council of the City of Portland, Oregon, for the vacation of the above mentioned street area, hereinafter described, that the City Auditor be and is hereby directed to give notice as provided by law for such vacation, that 9 30 a m , Wednesday, October 14, 1998, in the Council Chambers of City Hall, Portland, Oregon, be and the same is hereby fixed as the time and place for the hearing upon the contemplated vacation of said street area and upon all objections, remonstrances and/or claims for damages that may be presented and filed by that time
