In a cynical society the easiest way to get a laugh is to say "Hi! I'm from the government and I'm here to help you."

Because pollution prevention programs are not about opening the door to government regulators assessing fines and issuing permits P-2 programs restore the orig inal concept of government providing a service not a pain in the neck or a bite in the profit margin.

Pollution prevention having a positive effect on business and industry can help to restore trust in government.

Pollution prevention breaks down the "us" and "them" barriers. Stanley L Mason Jr. explains, "Nothing levels a playing field like a better idea."

The voluntary program helps the private sector see links between environmental benefit and business profitability.

Portland's P-2 leader Margaret Nover is like Robert Frost telling some students "I am not a teacher, but an awakener."

The achievements in preventing pollution show that government and business can work in concert not at odds. They can increase each others efficiencies.

Everyone benefits from pollution prevention because it reduces future capacity requirements for municipal wastewater treatment systems, regional garbage transfer stations and landfills. Natural resources can be saved, industry dollars can be retained for tangible community investment and government workers can be re-assigned from enforcement to education.

Pollution prevention insures a community's environmental and economic sustainability.

Pollution Prevention Recognition Award Recipients

Fuel cell and methane reuse
 Steve Behrendt, Wastewater Treatment Group

A by-product of the digester process at the Columbia Boulevard Wastewater Treatment Plant is methane. Methane previously flared solely to the atmosphere is now being reused to generate power with a fuel cell (a partnership with the Energy Office) and is being sold to a neighboring business as a source for heating

2. Citizen stewardship.

Paulette Rossi

Paulette volunteers her time and talent to serve on various committees and boards, such as the Public Utility Review Board, Stormwater Rate Advisory Committee, and is the chair of the Solid Waste sub-committee of the PURB. Paulette is a pinnacle for environmental concern, demonstrating her commitment to the environment by reusing materials in per personal life that are otherwise considered waste, and turning them into usable items.

3 Mobile solar generator.

Tom Ullman

Tom, "the tool man", runs the Maintenance Bureau's supply and tool room. With his interest in improving public service and alternative energy, such as solar, Tom invented a solar generator for a city meter repair truck, displacing use of internal combustion generators for electrical power while repair trucks are in the field. This unit saves money with its low maintenance feature, and is a clean technology, reducing adverse impacts to air quality.

4. Buckman Heights.

Pat Prendergast and Ed McNamara

A balance between ecology and human needs is met at the Buckman Heights Apartments, a 144 affordably priced apartment complex in Southeast Portland. In addition to an on-site car sharing program and bicycle amenities, the building features ecological

benefits such as recycling areas on each of its four floors, energy efficient design and use of environmentally preferable building materials. The facility also has a stormwater management system that returns all stormwater back in to the ground on the site rather than discharging to the sewer system.

5. Data analysis system.

Dennis Wodtli

Using an innovative data analysis system, the Bureau is able to identify problems at pump stations that previously might go unnoticed for months. Dennis created a system that takes telemetry data and views it in a manner that focuses on the potential or cause for problems rather than reacting to a problem after it has occurred. This data analysis system identifies potential overflow problems, allowing BES time to be proactive rather than reactive in responding to such situations.

6 Sulzer Bingham Pumps.

Tom Davis

Co-worker involvement, creativity, and cell competition are all methods used by Tom to promote prevention strategies within Sulzer Bingham Pumps. Tom's dedication to both the profitability of Sulzer Bingham and to environmental excellence resulted in business savings in excess of \$575,000 per year and related reductions of adverse environmental impact

7 Bulky waste collection.

Alison Stoll, Genny Seivers and Brian Goldberg
Reuse is a key component of pollution prevention, and through the
combined efforts of Alison, Genny and Brian, reuse is made easy
through the door-to-door bulky waste collection program
Appliances, furniture and tires collected from over nine
