The reason for the proposed vacation is to consolidate property The street area contemplated for vacation is more fully described as follows

Portions of SW 62nd Avenue south of SW Pomona Street, located in the northwest one-quarter of Section 31, T1S, R1E, WM, Multnomah County, Oregon and more particularly described as follows

Parcel I

All that portion of SW 62nd Avenue lying south of a line drawn between the northeast corner of Lot 6, Block 8 and the northwest corner of Lot 27, Block 9 Pasadena, and north of a line drawn between the southwest corner of Lot 25, Block 9 and the southeast corner of Lot 9, Block 8, Pasadena, City of Portland, Multnomah County Oregon

Parcel II

All that portion of SW 62nd Avenue lying in Lots 6, 7, & 8, Block 8 Pasadena, City of Portland, Multnomah County, Oregon, described as follows

Beginning at the northeast corner of said Lot 6, thence southwesterly in a straight line 68 0 feet, more or less, to the southerly line of said Lot 6, at a point which is 46 0 feet west of the southeast corner of said Lot 6, thence southerly in a straight line 50 0 feet, more or less, to the north line of said Lot 8, at a point which is 40 0 feet west of the northeast corner of said Lot 8, thence southeasterly in a straight line 47 0 feet, more or less, to the east line of said Lot 8, at a point which is 250 feet south of the northeast corner of said Lot 8, thence northerly along the east lines of said Lots 8, 7, and 6 a distance of 125 0 feet to the Point of Beginning
