

**RESOLUTION NO. 35804**

Appoint Roserria Roberts, Bill Van Vliet, and James H Winkler, and re-appoint Judy Estes, Janice Frater, and Michael Silver to the County-wide Housing and Community Development Commission. (Resolution)

WHEREAS, the City Council adopted Resolution No. 33056, January 6, 1982, establishing the Housing Advisory Committee to advise the City on matters of housing policy; and

WHEREAS, the City Council adopted Resolution No. 34156, August 20, 1986, clarifying the responsibilities of the Housing Advisory Committee, and

WHEREAS, the U.S. Congress passed the National Affordable Housing Act in 1990 which, among other things, required entitlement jurisdictions to adopt a Comprehensive Housing Affordability Strategy (CHAS); and

WHEREAS, the City Council adopted Resolution No. 34836, May 1, 1991, directing the Housing Advisory Committee to oversee the development of the local CHAS in conjunction with the City of Gresham and Multnomah County, and

WHEREAS, after an extensive citizen involvement process, the City of Portland (through Substitute Resolution No. 34918), the City of Gresham (through Resolution No. 1601), and Multnomah County (through Resolution No. 91-172) adopted the First Year CHAS; and

WHEREAS, under Goal A, Coordination and Leadership, of the adopted CHAS, Strategy A.1 states: "Establish a Countywide Housing and Community Development Commission"; and

WHEREAS, the City Council passed Ordinance No. 165302, April 8, 1992, establishing the Housing and Community Development Commission;

NOW, THEREFORE, BE IT RESOLVED, that the Commissioner appoint Roserria Roberts, Bill Van Vliet, and James H. Winkler, and re-appoint Judy Estes, Janice Frater, and Michael Silver as members of the Housing and Community Development Commission to represent the City of Portland in carrying out the duties as described in the amended Chapter 3 38 of the Portland City Code. The following list of members represent the City of Portland on the Housing and Community Development Commission. Term expiration dates are noted after each name.
