(Resolution).

- WHEREAS, the Association for Portland Progress formed the West End Steering Committee and West End Working Group to develop the West End Vision Plan in consultation with interested property owners, organizations, and residents; and,
- WHEREAS, the City Council acknowledges and applauds the work of the West End Working Group and Steering Committee and supports the concepts of the West End Vision Plan; and,
- WHEREAS, opportunities for citizen involvement are a fundamental element of effective planning and implementation;

- BE IT FURTHER RESOLVED that City Council directs the Bureau of Planning to provide staff support to the West End Advisory Committee;

- BE IT FURTHER RESOLVED that the West End Advisory Committee is charged with providing advice and consultation to city staff, the Planning Commission, and City Council, in evaluating the West End Vision Plan, in particular the action items that require City funding, or regulatory changes to implement;
- BE IT FURTHER RESOLVED that the West End Advisory Committee is charged with inviting input from the broader community as part of their input and advice process;
- BE IT FURTHER RESOLVED that the West End Advisory Committee is charged with advising staff on refinements to the Bureau of Planning's Discussion Draft and recommendation to the Planning Commission no later than July 2000.
