RESOLUTION No.

- Set hearing date for Wednesday, 9:30 a.m., December 8 , 1999, for the vacation of a portion of SW Bertha Court south of SW Capitol Highway. (Resolution: C-9974)
- WHEREAS, it appears to the Council that proceedings should be taken pursuant to ORS 271.130, for the vacation of a portion of SW Bertha Court south of SW Capitol Highway, in the City of Portland, Multnomah County, Oregon;
- WHEREAS, the reasons for the proposed vacation are to improve vehicular, pedestrian and bicycle facilities by constructing a new, realigned SW Bertha Court east of the existing SW Bertha Court, and to improve development opportunities for the vacant site to the west. The vacation of SW Bertha Court was recommended in the Capitol Highway Plan adopted by City Council in January 1996. The street area contemplated for vacation is more fully described as follows:

That portion of SW Bertha Court south of SW Capitol Highway in the City of Portland, County of Multnomah, State of Oregon, more particularly described as follows:

Beginning at the point of intersection of the south line of SW Capitol Highway and the east line of SW Bertha Court (Road 910): thence S 06°23'02" W along the east line of said SW Bertha Court a distance of 230.36 feet; thence N 83°36'58" W a distance of 30.00 feet to a point on the west line of said SW Bertha Court; thence N 06°23'02" E along the west line of said SW Bertha Court a distance of 220.00 feet to a point of intersection with the south line of said SW Capitol Highway; thence N 77°19'31" E along the south line of said SW Capitol Highway a distance of 31.74 feet to the Point of Beginning.

NOW THEREFORE, BE IT RESOLVED, that proceedings be and they are hereby initiated by the Council of the City of Portland, Oregon, for the vacation of the above mentioned street area, hereinafter described; that the City Auditor be and is hereby directed to give notice as provided by law for such vacation; that 9:30 a.m., Wednesday, December 8, 1999, in the Council Chambers of City Hall, Portland, Oregon, be and the same is hereby fixed as the time and place for the hearing upon the contemplated vacation of said street area and upon all objections, remonstrances and/or claims for damages that may be presented and filed by that time.
