- Authorize City Attorney to commence legal action against Edward Davis for damages to Cityowned tree (Resolution)
- WHEREAS, Edward Davis applied to the City Forester for a permit to remove a Spanish Chestnut tree in the right of way abutting his property at 4906 NE 33<sup>rd</sup> Avenue; and
- WHEREAS, the Forester denied the permit on the ground that the condition and circumstances of the tree did not warrant removal; and
- WHEREAS. Mr. Davis, under the provisions of PCC 20.40.100, appealed the Forester's decision to the Urban Forestry Commission, which affirmed the Forester's denial of a permit and recommended that Mr. Davis seek a permit for selective pruning of the tree; and
- WHEREAS, Mr. Davis did not appeal the Urban Forestry Commission's decision to the Council; and
- WHEREAS, Mr. Davis, through his lawyer, sent a letter to the City complaining of the decision to deny permission to remove the tree; and
- WHEREAS, the City Attorney responded with a letter to Mr. Davis' lawyer reminding Mr. Davis of his responsibility to maintain the tree under the City Code; and
- WHEREAS. Mr Davis, without a permit, cut and seriously damaged the tree; and
- NOW, THEREFORE, BE IT RESOLVED that the City Attorney or his designee is authorized to commence an action for damages and other appropriate relief, in any court of competent jurisdiction against Edward Davis and any other person who may be responsible for damage to the City-owned tree in the right of way abutting 4906 NE 33<sup>rd</sup> Avenue, and, in furtherance or resolution of such action, is authorized to make any stipulation, agreement or admission as in his judgment may be in the best interest of the City.
