Dear Mayor Potter and RFP Review Committee:

I write to express my strong support for the application by VOZ to create and operate a day laborer center in Portland. Based on my experience in working with VOZ, I can think of no other organization that is better suited for this assignment. VOZ has effective leadership, dedicated staff, a strong commitment to serving clients, a deep understanding of the client community and ten years of directly related experience. I am familiar with the work done by VOZ because I am the attorney at Oregon Law Center assigned to serve the day laborers and low wage workers in this region. The Oregon Law Center is a nonprofit corporation providing free civil legal services to low-income people in Oregon.

I am extremely impressed with the leadership skills of Ignacio Paramo and Romeo Sosa and the important work they have done for day laborers and other low-wage workers. Mr. Sosa and Mr. Paramo are effective advocates who have effectively maximized minimal resources to educate day laborers and low wage workers on their employment rights. They have treated each client with dignity and respect, helping them grow as individuals and members of this community. Regardless of the weather conditions, you will often see Mr. Sosa and Mr. Romeo out on the street corner with workers educating them on their rights while these workers wait to be hired for employment. VOZ has a proven track record of empowering workers to ensure that they receive a living wage and safe working conditions. VOZ also assists workers who are not paid by employers for the work that they performed and educates day laborers on how to minimize the risk on not being paid for work.

VOZ has successfully developed relationships with community partners, such as the Oregon Law Center, to increase its ability to serve day laborer populations. VOZ looks for potential resources

and successfully develops the relationships necessary to help their clients get additional resources. Most lawyers do not have the capacity to represent immigrant populations on employment matters because of language barriers and high cost of legal fees. VOZ refers underserved immigrant populations to the Oregon Law Center when legal action becomes necessary to pursue wage claims against an employer who takes advantage of a day laborer's vulnerability and dire necessity to earn wages. VOZ has developed good working relationships with many community partners and has a positive reputation in the community. VOZ has worked with law enforcement, local businesses and residents to educate the community about the population that VOZ serves and to dispel misconceptions about the nature of day laborers' presence in the community.

VOZ has demonstrated a 10 year commitment to educating and advocating on behalf of day laborers and low wage workers. VOZ is well known and trusted by the community it serves. Because people are scared and vulnerable, it is difficult to build trusting relationships in this community. VOZ has the staff, skill set and commitment to ensure that a day laborer center is run effectively. A day laborer center will allow VOZ to continue its grassroots effort to advocate for low income workers in a safe and sheltered environment. I am confident that VOZ will continue to advocate on behalf of low income workers and to work closely with community partners to ensure the longevity of a day laborer center.


I am writing in support of the application submitted by VOZ Workers Rights Education Project seeking funds from the City of Portland to finance the creation of a day laborer hiring site in Portland.

I have lived and worked in Oregon as an attorney for over 30 years. Much of that work has been dedicated to representing and supporting low-wage and immigrant workers; formerly as director of the Oregon migrant legal services program and, currently, as the cofounder and Executive Director of the Portland-based Northwest Workers Justice Project (NWJP), a non-profit organization that supports low-wage, immigrant and contingent workers through education, advocacy and direct legal representation. See, www.nwjp.org for more information.

In these years, I have watched as conditions for our city's low-wage and immigrant workers have steadily deteriorated below legal standards. Immigrants are not the only workers affected by this lawlessness. U.S. workers' standards are also directly affected by exploitation of hard-working wage earners, since decent employers must compete with those who would cut corners, placing downward pressure on wages and working conditions for all. Day laborers are among the most vulnerable of these workers—facing frequent exploitation, routine discrimination, and extreme instability.

I have also seen VOZ emerge as a critically important organization—and virtually the only organization in Portland—supporting these workers in their efforts to organize and defend their rights. VOZ has been able to create at least some level of coherence in a street corner labor market that otherwise lacks any standards of human decency. With VOZ's leadership and encouragement, day laborers have begun to insist on minimum standards of employment. With VOZ's help they have begun to take steps to enforce their rights to be paid for their work. But without an actual physical space to gather, these efforts are ultimately limited.

In cities throughout the country, it has been demonstrated that workers centers can be effective in increasing employer accountability and lowering conflicts with surrounding businesses and neighborhoods. However, an essential ingredient in this success is the credibility and perceived reliability of the center's sponsor. Unless workers come to the center to look for work, participate in developing the policies of the center and support their implementation, a new labor center will fail to become the vital locale in the City for recruitment of casual workers. And without becoming that critical situs, a center will not be able to achieve any of its goals of
