Katz: good morning, everybody. Will the council come to order. Britta, call the roll. Both commissioner Hales and Francesconi are on vacation.

Item 1143.

Mike Rosenberger, Director, Water Bureau: mayor Katz and members of the council, I am mike rosenberg, director of the water bureau. The report you have is pursuant to ordinance 174728. That required that when the proration of the water and sewer rates between the last and current fiscal year would be ready to go into operation, that a report would be filed with the auditor's office and those rates would be effective the next day, and then the ordinance required a report to the council, just to make sure that you knew that that happened. And so the proration took effect on the 31st of july, the auditor's office was noticed and as of august 1st, we put it into place. It is working and the money is being collected. We are making progress. The walls are going on but that's another subject.

Katz: All right.

Sten: that's what you know. I want to commend you for keeping to your very tight deadline that you set for yourself. in getting this done.

Rosenberger: we are working hard, very hard.

Katz: You are tired and I am sure that everybody is working very, very hard from all the e-mails that have been floating around.

Rosenberger: yes, ma'am.

Katz: Yeah. Okay. Thank you. Acceptance of the report. Do I hear a second? A second? Roll call.

Katz: Mayor votes aye. I think that next week we will have everybody back.

Olson: yes—no, not next week.

Katz: Not next week, the week after, so in two weeks, the schedule should be very, very heavy. All right. Thank you, everybody. And we stand adjourned.
