AGREEMENT FOR PROFESSIONAL, TECHNICAL, OR EXPERT SERVICES

SHORT TITLE OF WORK PROJECT: SUMMER YOUTH EMPLOYMENT PROGRAM

Pursuant to Ordinance No.

Contract No: 37275 was made and entered into on April 24, 2007, by and between Immigrant and Refugee Community Organization, hereafter "Contractor" and the City of Portland, a Municipal Corporation of the State of Oregon, by and through its duly authorized representatives, hereafter "City".

1. Contract No: 37275 is hereby extended through December 31<sup>st</sup>, 2008.
2. Additional deliverables, schedule and work are necessary as described in the Statement of Work as follows:

- a) Beginning date to design, implement, manage, and evaluate the SYEP shall be April 11, 2008 or the latter date at which every party has signed the Contract.
- b) The program operation dates are from June 16, 2008 through August 15, 2008.

The number of participants selected will be no less than 50 and no more than 70 students.

- ii) The management system to train, employ, and pay participants are from June 16, 2008 through August 15, 2008.

The stipend training period dates are June 16, 2008 through June 27, 2008.

The participants' employment dates are June 30, 2008 through August 15, 2008.

The participants' employment hours from June 30, 2008 through August 15, 2008 are between 20 and 25 hours per week at \$7.95 per hour which is the prevailing minimum wage.

The number of participants compensated by the payroll system will be no less than 50 and no more than 70 students.

- vii) The construction trade apprenticeship program training dates are June 16, 2008 through June 27, 2008.

- c) The final written project report submission date is no sooner than August 15, 2008, but no later than August 29, 2008.

3. Additional compensation is necessary and shall not exceed \$185,000.00 for the Contact No: 37275 extension.

The City agrees to pay the Contractor \$185,000.00 for materials and services rendered. Payment will be made according to the following payment schedule upon delivery of invoices beginning June 16, 2008 from the Contractor for services which have been completed:

Payment 1 - The City will pay the Contractor \$65,000.00 between June 16, 2008 and June 30, 2008 for satisfactorily completing the recruitment, screening, selection, and coordination phases of the 2008 SYEP.

Payment 2 - The City will pay the Contractor the balance of the Contract of \$120,000.00 upon receipt of invoices for payment between July 1, 2008 and August 29, 2008 with final payment due upon submission of the final report on August 29, 2008 for satisfactorily coordinating the SYEP.

All other terms and conditions of Contract No: 37275 shall remain unchanged and in full force and effect.
