### **HEARINGS OFFICER'S ORDER**

CITY OF PORTLAND, petitioner, vs. DORENE L. KIEST TR, respondent(s)

#### FINDINGS OF FACT AND CONCLUSIONS OF LAW:

Mr. Steve Kass, Inspector for the Bureau of Development Services, appeared and testified on behalf of the City. Mr. Craig Kiest, son of Respondent, appeared and testified that he was authorized to represent Respondent. The Hearings Officer makes this decision based upon the testimony of Mr. Kass and Mr. Kiest, and the exhibits admitted into the evidentiary record.

Mr. Kiest admitted that the violations listed on Exhibit 20 did exist on the date of the first hearing (December 3, 2008). Mr. Kiest indicated that the violations would be corrected in a timely manner and requested that the civil penalties requested by the City be reduced. Mr. Kass agreed that if the violations were corrected in a timely manner the City would be agreeable to reducing the amount of its requested civil penalties.

A second hearing was scheduled for December 8, 2008, at which the time Hearings Officer set a third hearing for December 9, 2008. At the third hearing, Mr. Kiest and Mr. Kass appeared and confirmed that all violations had been corrected and that a civil penalty in the amount of \$1,811 (cost of City inspections and cost of taking the case to hearing) was appropriate.

The Hearings Officer, therefore, finds that all violations listed on Exhibit 20 have been corrected and that a civil penalty in the amount of \$1,811 should be awarded to the City and imposed as a lien against real property described as 7334 SW 28th Avenue, City of Portland ("Subject Property").

## ORDER AND DETERMINATION:

- 1. A civil penalty in the amount of \$1,811.00 is hereby imposed, said penalty to be due and payable immediately; such amount to be made a lien against the Subject Property on December 29, 2008 if not paid in full.
- This order has been mailed to the parties on December 11, 2008, and shall become final and effective 2. on December 26, 2008. Any objections to this order must be in writing and received by the Code Hearings Office prior to the effective date. This case will be closed on December 30, 2008.
- This order may be appealed to a court of competent jurisdiction pursuant to ORS 34.010 et seq. 3.
