OFFICIAL MINUTES

A REGULAR MEETING OF THE COUNCIL OF THE CITY OF PORTLAND, OREGON WAS HELD THIS 26TH DAY OF JUNE, 1991 AT 9:30 A.M.

THOSE PRESENT WERE: Mayor Clark, Presiding; Commissioners Blumenauer, Bogle, Kafoury and Lindberg, 5.

TIME CERTAIN: 9:30 AM - Accept report on modification of time limits and parking rates for downtown parking meters as submitted by the Bureau of Traffic Management (Report introduced by Commissioner Blumenauer)

Discussion: Commissioner Blumenauer said today's report is an effort to continue good management of downtown parking, which is essential to the vitality of the downtown urban core. The most important recommendation is to change metering system times to match up with citizen needs and improve the availability of on-street parking. He said expansion of the number of one-hour meters will greatly increase the convenience to those who come downtown. He also noted that few other cities have rates as low as ours, even after the proposed increases.

Elsa Coleman, Parking Manager, said the overall goals of the proposed program are to: simplify the system; integrate on-street parking with City-owned garages; manage by sub-area to meet individual area needs; increase turnover; and replace aging meters.

Bob Andrews, Parking Management staff, described some of the changes, including replacement of the existing meters with electronic ones; reduction of the number of meter time limits from six to three; and equalization of on-street parking rates with rates at City-owned garages to 75 cents an hour.

Bill Palmer, Downtown Retail Council, noted that the current 30minute meters do not allow sufficient time to meet the needs of shortterm parkers, whose average stay is 47 minutes.

Robert Freedman, Director, Portland Center for the Performing Arts and a member of the Advisory Council, said they believe the changes will add parking spaces for people coming downtown to purchase tickets for Performing Arts Center events.

Transmit a report to establish procedures for economic improvement districts (Previous Agenda 1065)

Discussion: Commissioner Blumenauer said getting the downtown business community to voluntarily assess themselves to help maintain the vitality of the urban core is one of the City's true successes. He said working out the financing has been one of the most convoluted conundrums he has seen in government finance.

Ruth Scott, Association for Portland Progress, said the first district was a three-year district which sunsets in Sepember. The new district has been convoluted by Measure 5 which requires that anyone who wishes be removed from the district. She said the final plan will be presented in July, followed by a public hearing on housing and religious exemptions. A hearing on the assessments will then be held in September.

Doug Goodman, Chairman of Economic Improvement District Advisory Committee, said the current program works and is looked to as a model by many other cities which are now in the process of putting their own versions together. He said the public/private partnership is what has made Portland's district successful. He said 75 percent of those in the district have voluntarily committed to the continuation of the program and urged its reestablishment.

Tammy Hinkle, APP Board member, said the message that Portland is a clean, safe and exciting place must continue to be promoted.

Bill Naito, APP Board member, noted that quite a number of homeless have been given jobs through this program. If Portland wants a viable and clean downtown, it needs to continue this program.

Lee Lacey, President, Downtown Community Association, stressed the importance of the district in keeping downtown safe and clean.

> **Discussion:** Laurel Wentworth, Office of Transportation, described the matching obligations for the project, noting that \$7,000,000 has been committed by the City, \$1,000,000 of which has already been provided from the Office of Transportation's current fiscal year budget. She said it was imperative for the participating governmental entities to make binding commitments to Tri-Met to pay their respective shares of the local match.

Commissioner Blumenauer said this is a critical piece to keep the momentum going for light rail. He said he is convinced the City will get far more out of it in terms of business vitality and savings in transportation costs than what it pays.

Tom Walsh, Tri-Met Manager-Elect, said amazing progress has been made on this project in recent months and negotiations are going very well.

Discussion: Cay Kershner, Clerk of the Council, said a substitute has been introduced. Commissioner Lindberg moved the substitute; Commissioner Bogle seconded and the motion carried. (Y-5)

Linda Dobson, Assistant to Commissioner Lindberg, said Metro has come to the City for approval, in concept, for fee parking at the Zoo/OMSI/World Forestry Center lot so that it can meet its matching obligations for the Westside Light Rail project. The Parks Bureau owns the lot and leases it back to the three institutions. If the concept is approved, a detailed study will be made on the impacts. If a fee is continued after the debts are retired, the City would expect to share in any revenues. The resolution also calls for the Parks Bureau to prepare a new lease. She said there are many unknowns at this point and they plan to return to Council later with a detailed analysis.

James Wilkes, Western Forestry Center Development Director, said approval of the resolution is premature because of so many unknowns. These include parking for those visiting the Vietnam Memorial, added costs for families visiting the park and spillover parking into the adjoining neighborhood.

Mayor Clark said these issues concern him also and that the study will help answer them.

Mr. Wilkes questioned the reasonability of the fee revenues cited in Commissioner Lindberg's memo. He called for the resolution to be tabled.

Commissioner Lindberg said he shares the concerns raised but is willing to approve this conceptually while realizing that there are dozens of issues to be studied.

Commissioner Blumenauer said this resolution provides the framework to look at all the issues, many of which have been raised before.

Commissioner Kafoury said she had strong concerns about the costs to local families.

1144 Report on the first year of Community Policing implementation (Report)

Discussion: Tom Potter, Chief of Police, reported on the first year of the five year transition to community policing. He described some of the measures taken during the first year, highlighted by creation of the Chief's Forum to advise on major policy issues, creation of Biased Crimes Unit and assignment of dectectives to the precincts in the gang enforcement teams. They also have trained all Police Bureau members in cultural awareness, community organizing and in problem solving. A revised drug enforcement policy has placed neighborhood liveability as its first priority and the neighborhood liaision program has been expanded. He said they are also working on establishment of a regional drug enforcement policy and continuing with the landlord drughouse training. In addition, Chief Potter said they are analyzing maximum use of their resources, and are working to implement the Citizens Crime Report.

Chief Potter said Police have learned from citizens that they want to see more officers out of their cars and more attendance at community meetings. They also want more enforcement of drug-house regulations. Next year the Bureau wants to increase training and implement an affirmative action hiring plan so that the Bureau will truly represent the diversity of the community.

Mayor Clark asked about the effect of Ballot Measure 5.

Chief Potter said he assumed that without Measure 5 the Police would have been given increased resources to respond to community problems, instead of having to shift things around.

1145 Adopt the Community Policing Transition Plan Attributes and Success Factors (Resolution)

> **Discussion:** Chief Potter said the attributes and success factors encompass the goals of community policing. These include increased neighborhood livability, reduction in crime and empowerment of citizens and officers.

Richard Brown, Police Chief's Forum, described some of the steps that have been taken to make community policing work.

Jim McPhillip, member of the Police Chief's Forum, said the business community is very pleased with Police Bureau response to its recommendations. He said it is concerned with the need for additional Police staff and recommend appointment of a Task Force to look at stable funding levels for the Bureau.

Haven Baxter, Police Officer, 22-year Police veteran, said community policing has opened a door that allows officers to get involved with the community and encourages the community to get involved in government.

Laurie Moeser, Arnold Creek Neighborhood Association Co-Chair, supported creation of the committee. She said it makes good sense to have periodic review of land use requirements. She said one concern they have is the lack of notification on smaller applications, such as minor partitions.

Thomasina Gabriele, Chair of Regulatory Review Committee, said all the major players in the area appear to be represented on this committee. She said all the issues will be examined on a one-by-one basis.

Commissioner Kafoury said we should hear how much less this is than it used to be.

Tim Grewe, Director of Financil Planning, said the state revenue sharing has remained pretty flat over the past several years. He said in the case of federal revenue sharing, all the funds, about \$11,000,000 have gone away.

> **Discussion:** Commissioner Blumenauer complimented the public and staff for their commitment to taking the most complex local collection system in the country and finding solutions to turn it into an efficient process.

Sue Keil, Bureau of Environmental Services, described the "corraling" process used to determine the assignment of territories. She said territory assignments will be brought to Council in late July for approval and that they are now in heavy negotiations with the haulers on the franchise agreements. She said the recycling delivery system goals are to encourage increased curbside recycling by upgrading the service, expanding the types of recyclables and consolidating the routes to fully utilize state-of-the art recycling methods and equipment.

Ms. Keil reviewed the rationale for establishment of recycling districts for smaller haulers with fewer than 3,000 customers, noting that the two major components of efficiency are routing and equipment. She said the equipment is expensive and only becomes cost effective at the 3,000 customer per week level. Commissioner Blumenauer said we are talking about sustainability and the need to put something in place that will work for five or more years.

Stan Kahn, Sunshine Recycling, 722 SE 18th, asked for an exemption of his company from the standards that mandate a recycling consortium for companies with less than 3000 customers. He said his company's equipment will be idled while it pays someone else to do its recycling. He pointed out his pioneering efforts and 18-year commitment to innovative recycling methods.

Mayor Clark recognized that Mr. Kahn has been involved in recycling right from the start. He suggested using Mr. Kahn's expertise in some manner under the new system.

Commissioner Blumenauer said he also recognized Mr. Kahn's demonstrated track record. He said they looked at a way to grant exemptions but have found no way to do so that keeps faith with the other parties.

David McMann, Cloudburst Recyling, said it has been their longtime goal to see the City adopt a quality, comprehensive recycling system. He said he is not thrilled about going to a geographically-based route or other aspects of the program but is willing to make sacrifices in order to move forward.

Judy Roumpf, 3345 NE 27th, said the proposed system, with 17 different recycling operators, is not efficient enough. She asked Council to amend the ordinance to make efficiency a priority and called for routes of 12,000 customers each within five years.

Dennis Gilman, 1313 SE Oak, said it is important that innovative and committed companies like Cloudburst and Sunburst be allowed to continue in business. He suggested making performance the standard, not size.

Bruce Lewis, Elmer's Sanitary and a member of the steering committee for East Side Recycling Committee, said there is a certain amount of hurt among haulers that will not be allowed to continue. He said he believes innovation is not dead just because large districts have been formed.

Commissioner Blumenauer noted Ms. Roumpf's argument that the districts are too small. He said the new system will be more

regulated but that Council is committed to looking at innovation over time. However, right now the ground rules that allow the City to move forward must be provided. He said the Bureau believes that what is proposed is a reasonable cutoff.

Mayor Clark said hopefully the rules will open up new and expanded opportunities for recyclers, haulers and residents of Portland. He said it will allow the City to test innovation in a controlled situation.

> **Discussion:** Ron Bergman, Acting Director, Bureau of Administrative Services, said all the organizations had been notified about this action.

> Joanne Allen, Black United Front, said she was concerned about the effect the 25 cent per payroll deduction charges would have on small contributions of \$10 or so.

Mr. Bergman said the fee was intended to be considered as an administrative expense against the organization and a part of its overhead.

Commissioner Blumenauer said a minimum threshold should be set so that the contributions are sizeable enough to make the payroll deduction worthwhile.

Mr. Bergman said the fees will be used solely to recover the cost of one employee who spends full time administering the voluntary deductions. The cost is approximately \$28,000 a year.

Valerie Brown, United Way, said they are concerned with the precedent the City is setting and asked for a deferral.

Don Skinner, Environmental Federation of Oregon, echoed Ms. Brown's concern with the precedent this sets. He protested the lack of prior involvement and also asked for a deferral to allow time to look at other options.

Ernst Snook, American Family Life Assurance Co., said one-fifth of City employees are enrolled in his company's insurance programs and are thus subject to payroll deductions. He said a better solution would be to allow their premiums to be treated as a pretaxed deduction. That would immediately save the City approximately \$7,650 and would generate four times the amount the proposed service fee would give them.

Barbara Clark, City Auditor and a member of the Police Historical Society, said the Society supports the concept of user fees for special services but wishes to point out that the fees affect 36 organizations of which only 10 will be subject to the fees.

Commissioner Kafoury said the City has done a very poor job of promoting charitable contributions compared to the County. If the City agreed to have a more aggressive fund-raising effort perhaps some tradeoff could be made on the deduction fees. She asked for a deferral for several weeks.

Mr. Bergman said as of July 1 he will not have the budget to fund the position.

Commissioner Blumenauer said Council had considered this issue before and made the decision during the budget process that they would recover the cost of this service. He said the issues raised should be considered but Council should go ahead and follow through on the decision already made.

Mr. Bergman said if a better way to do it was found the ordinance could be cancelled. He explained the notification process on this issue.

Commissioner Kafoury said she would like to commit to increase our participation in charitable giving by about 20 percent. She said a minimum threshold does need to be implemented.

Mayor Clark said he agreed with Commissioner Blumenauer, noting that it had been discussed at length during the budget process.

Mr. Bergman said 75 percent of the revenue will come from the Credit Union and deferred comp programs.

Commissioner Bogle said it would be a good idea for those people speaking today to have a forum so adjustments could be made later on.

	Discussion: Gail Curtis, Planning Bureau, said this is the third in a series of environmental mapping plans being done to update the City's Comprehensive Plan and to conform to LCDC statewide planning Goal Five. The Plan is a major step to protect and restore the natural resources in Johnson Creek and the entire ecosystem. The Plan places two overlay zones on the man - an onvironmental

The Plan places two overlay zones on the map - an environmental

protection zone where development should be restricted and an environmental conservation zone where development can be accommodated with mitigation. The Plan sets the framework for future work the City will be doing with the Johnson Creek Management Plan, the major tool for restoration. Citizen involvement has been extensive, including meetings with seven neighborhood associations and 12 other groups with a direct interest in protecting the area.

Ms. Curtis said citizen involvement molded the Plan, resulting in the Johnson Creek Plan District. Because the creek basin consists of so many small residential parcels, they ended up decreasing the buffer area along the creek to give property owners more flexibility. In turn, the overall area to be protected was expanded to cover the Boring Hills and Mt. Scott areas which will provide more protection from erosion and runoffs. She said they also created exceptions for property owners to allow modifications without environmental review where there is no expansion. Another recommendation was to move the 40 Mile Loop trail to the Spring Water line.

She said this is just one of several steps necessary for restoration of the Creek, the first being creek cleanups organized by the residents themselves. The Protection Plan offered today is the second step and the Management Plan to be implemented by the Bureau of Environmental Services is the third.

Ms. Curtis recommended taking all public testimony today and then having staff return with a summary of responses to the issues raised. She said an errata sheet had been distributed showing some minor mapping changes.

Steve Johnson, 3707 SW Johnson Creek Boulevard, said his recent return has brought home how much the City has encroached upon the creek area. He said they need to pay attention to the edges and urged expansion of the environmental protection areas.

Linda Bauer, Pleasant Valley Neighborhood Association, protested the V overlay as called for in Code section 33.535.200. She said 33.535.320, additional approval criteria, adds back guidelines which fuzz up what was approved under the new zoning code passed in Janaury.

Merrie Miller, 6558 SE 108th, Landowners and Friends of Johnson Creek, said her group is fighting to prevent the destruction of area wetlands and neighborhood degradation. She complimented Planning staff but affirmed Ms. Bauer's concerns about 33.535.320.

Stephen Janik, attorney representing Herb Althouse of Tom Moyer Theatres, requested deletion of a two-acre site owned by the Theatres from the EC zone and also asked that language relating to potential regulation of the 16-acre drive-in site be deleted. He said no evaluation had been done and there is no factual basis to support such action, which if applied would drastically reduce the industrial capability of the properties.

Michael Obrist, 17232 SE McKinley, owner of seven acres at 14346 SE Foster, protested the amount of property he will be forced to donate under the proposed EC zone.

Commissioner Kafoury said it would be helpful to have the staff present the choices on those issues that cannot be resolved at the staff level.

Joyce Beedle, 6622 SE 108th, voiced concerns regarding building and flooding. She said if her home burns down she must seek an adjustment which, if denied, would render her property worthless. Regarding flooding, she said she is not clear on the actual recommendation on creek stabilization. She said she wants to be able to reinforce her property with riprap, bring in fill and establish an earth berm without incurring the cost of an evaluation.

Mr. Brown suggested closing verbal testimony today but leaving written record open for one week, until 5 p.m. July 3, 1991. Council agreed.

Mr. Brown said they expect to circulate their responses to the issues raised today a full week before the next hearing.

Disposition: Passed to Second Reading July 17, 1991 at 2:00 p.m.

Commissioner Bogle moved to elect Commissioner Lindberg as President of Council to serve until December 31, 1991. The motion carried. (Y-4)
