1912 Accept report on Water System Revenue Bond sale (Report)

Discussion: Commissioner Lindberg said an extraordinary effort on the City's part has resulted in its receiving the highest bond rating possible for this type of bond.

Ken Rust, City debt manager, said they are very pleased with this upgrading in the level from Aa to Aal, a significant achievement reflecting the City's good management policies, and one that allows the City's bonds to be sold at a lower interest rate. In this case, the winning bid for these bonds was at a 5.31 percent rate, resulting in a savings of \$140,000 over the life of the bonds.

Appeal of Marshall Park Neighborhood Association against Hearings Officer's decision to approve application of Eleanor Shutte and Kathleen Farnsworth for an eight-lot subdivision with adjustments located at 10080 SW 25th Avenue at SW Huber Street (Previous Agenda 1904; 95-00499 SU AD)

Discussion: Mayor Katz noted that legal counsel has confirmed that Council may take a tentative vote and still accept additional information afterwards.

Duncan Brown, Planning Bureau, said the written record was kept open for seven days following last week's hearing. Two items were filed raising transportation issues. They are covered in Items 6 and 7 in the supplemental findings before Council for approval today.

Commissioner Kafoury moved to uphold the Hearings Officer's decision, override the appeal and adopt the supplemental findings. Commissioner Hales seconded.

Commissioner Kafoury said it is abysmal that the applicant had to go through this kind of run-around and was given such conflicting information by City bureaus. She said this is a further challenge to Commissioner Hales and herself to come up with a seamless development process that prevents such occurrences if the City is to succeed in building 50,000 additional housing units.

Mayor Katz said amen.

1940 TIME CERTAIN: 2:00 PM - Provide comments on the preliminary Regional Water Supply Plan (Resolution introduced by Commissioner Lindberg)

Discussion: Commissioner Lindberg said this resolution responds to the concerns expressed by Council members at the November 9 Council Informal. The resolution does not accept the recommended plan brought before Council then but instead lists the critical issues and positions that Council believes reflect citizen values. The City understands that some of its regional partners have different needs and does not intend to dictate policy to them. However, the City needs to be clear about what will and will not work for it. Six key positions are expressed: 1) continue to use Bull Run as the City's drinking water supply; 2) emphasize conservation, particularly outdoors; 3) aggressively explore "green" alternatives, including dual water use; 4) urge reconsideration by the region of the reliability issue and whether building a level one system is wise; 5) reaffirm responsibility for stewardship of resources that may be needed in the long run, including cleanup of the Willamette; and 6) establish a regional consortium to work through the difficult jurisdictional issues. He said he has a letter requesting that the Governor create a new Willamette River Basin Water Quality Commission which he will circulate for Council signatures.

Frank Gearhart, Citizens Concerned about Bull Run, said after a four-year process, the City has a fairly sound position which calls for sticking with the Bull Run. He thanked the City for seriously looking at this and said his only reservation is whether language stating that an additional look at building a third dam should have been included.

Bob Robinson, 2226 SE 35th Place, opposed the emphasis on a regional plan. Portland should not be giving water to other communities as it does not have enough water to meet its own needs, particularly with the addition of new micro chip plants. He agreed with the emphasis on securing maximum protection of the Bull Run and Little Sandy watersheds. The regional approach could mean that Portland will eventually have to tap in the Columbia and Willamette whether it wants to or not. He hopes that a way can be found to build a third dam and add to reservoir capacity.

Randy Tucker, Oregon State Public Interest Research Group (OSPIRG), submitted 500 postcards which call for giving top priority to water quality and public health as well as conservation measures that save the best water for drinking. They also support an open public process. He said the City has moved in that direction, particularly with its emphasis on raw water quality and its move away from level one reliability.

Regna Merrit, Oregon Natural Resources Council, thanked Council for responding to earlier citizen concerns and for moving away from the use of dirty water sources. Some citizens expressed a desire for another public hearing. A large constituency also believes planning dollars should be used to look closely at a raw water source with a separate conduit system, such as the Little Sandy. With the loss of two out of three conduits this winter, the City would have been in bad shape without the well fields.

Michael Rosenberger, Director, Water Bureau, said this resolution will guide the Bureau in its ongoing conversation with its regional partners. They expect to hold additional public hearings and then return to Council in late February with the next draft.

Mayor Katz asked Mr. Rosenberger if he believes this resolution will be acceptable to the regional partners.

Mr. Rosenberger said this should be a positive influence in the debate even though the City Council's perspective is not the same as everyone else's. He is optimistic about achieving a plan the region can adopt.

Commissioner Kafoury said this is significantly better than the City's original position and responds to her concerns about the need for an earlier emphasis on conservation. She is not, however, ready to say that a third dam is needed in the Bull Run. Conservation and the "green" aspects should be pushed first. Also, she is very committed to a regional, not isolationist, solution even though all may not yet share the same values.

Commissioner Hales agreed with Commissioner Kafoury about the need to be a responsible partner with the other regional water agencies in planning for the future. That participation needs to be based on a set of principles and he is very comfortable with these. The construction of a third dam is an option that should remain open and the emphasis on conservation is appropriate. The resolution also responds to what Council heard from the community about the water supply system it wants in the future.

Commissioner Lindberg noted Council's substantial involvement in shaping this policy. He has been asked if this would still be a good plan in the event of a natural catastrophe. He believes it is, noting that the well field worked well as a backup system when two out of the three Bull Run conduits were damaged by mud slides. He said access to more well field water will increase its role as a backup system in the future. He noted that during the 1993 drought, Portland obtained water from other jurisdictions, illustrating the

desirability of regional cooperation. City ratepayers have also saved many millions of dollars because they have been sharing this water, an average of about 22 percent over more than a decade.

Mayor Katz said this represents Council's own values. She supports it wholeheartedly but still would like to know the ownership and governance of this plan. Who will make the final decisions? What will it cost and will this cost be equitably shared? That is the bottom line.
