A REGULAR MEETING OF THE COUNCIL OF THE CITY OF PORTLAND, OREGON WAS HELD THIS 4TH DAY OF FEBRUARY, 1998 AT 2:00 P.M.

THOSE PRESENT WERE: Mayor Katz, Presiding (late); Commissioners Francesconi, Hales, Kafoury and Sten, 5.

OFFICERS IN ATTENDANCE: Cay Kershner, Clerk of the Council; Ben Walters, Deputy City Attorney; and Officer Chuck Bolliger, Sergeant at Arms.

Commissioner Hales presided until the Mayor's arrival.

Discussion: Commissioner Hales moved the substitute, Commissioner Francesconi seconded, and the motion carried. (Y-4).

Commissioner Francesconi said more cops are needed on the street but there is a cost to the General Fund of \$1.1 million. Once they are added the continuing cost to retain them rises to about \$4.5 million in cost to the taxpayers. In the meantime, other ways of preventing crime have been underfunded.

Commissioner Kafoury noted that this grant requires a match while the other, larger • one the City has applied for does not.

Disposition: Substitute Ordinance No. 171973. (Y-4)

*120 Accept an additional grant award of \$8,000 from the Department of Justice, Criminal Justice Division for Marijuana Task Force (Ordinance)

Discussion: Paul Richmond, PO Box 454, 97207, said he agrees with the <u>Oregonian</u> editorial calling for an evaluation of the "knock and talk" policy before this grant is accepted.

Discussion: Mr. Richmond said many of the recent tragedies involving the police

have occurred not as a result of a lack of police officers but from a lack of training. There are not enough experienced officers and more training should occur before more new ones are hired.

Commissioner Hales said there is currently a backlog in hiring and this authorizes more. He asked what more can be done regarding the long time table between screening and training.

Dave Butzer, Chief of Services Branch, said the issue is the Bureau's ability to select and train a large number of new officers due to the high number of retirements that have occurred this year. The Bureau projects hiring 130 people in the next year and has added to its recruitment staff. Its ability to enroll people in the State training academies is limited and that is a problem too. He noted that the number of recruits needed runs in cycles, making it difficult to staff recruitment efforts at the appropriate level. The Bureau is trying to be innovative, using part time investigators, for example, rather than adding permanent staff.

Commissioner Kafoury asked for information about the long term cost of continuing to employ these officers at the conclusion of the grant period.

Commissioner Francesconi asked how the additional officers will be deployed and if any will go to the traffic division.

Bruce Prunk, Chief of Operations, explained how the traffic division is staffed. He said each precinct has identified ten sites where enhanced traffic enforcement is occurring.

Commissioner Francesconi asked about minority hiring efforts.

Chief Butzer said they are considering hiring a recruiter and using the Internet to increase the number of out-of-state applicants. Minority applicants will be sought specifically.

Commissioner Francesconi said officer training had nothing to do with the recent tragedies that have occurred.

Discussion: Bruce Wade, Portland Development Commission (PDC), said the residential rehabitation exemption program, due to sunset December 31, 1997, was

extended an additional 10 years by the State and also by the City. He said these changes are procedural and will have no fiscal impact. He said the affordability agreement is a substitute for the rent agreement which they found difficult to administer and inconsistent with State provisions. The amendment in Chapter 3.104 grants PDC the authority to determine a reasonable rate of return, something that has not been included in the Code before.

Commissioner Kafoury moved the amendment on page five. Commissioner Francesconi seconded and the motion carried.

Mayor Katz arrived and assumed the Chair.

Discussion: Bob Clay, Planning Bureau, said this represents a year of hard work by Commissioner Hales and Multnomah County Commissioner Dan Saltzman and implements an agreement giving the Planning Bureau the responsibility for regional planning services. It also meets Title 3 requirements of Metro's Functional Plan and will apply environmental zones and Goal 5 requirements to the unincorporated areas of Multnomah County where nothing has happened for 20 years.

Commissioner Kafoury asked when the rest of Multnomah County's Planning Bureau will merge with the City.

Mr. Clay said as part of a separate agreement, both jurisdictions are considering having the City administer the Zoning Code in the unincorporated areas and examining differences in administration costs. An assumption has been made that Multnomah County would do planning in the rural areas, which is currently the almost exclusive focus of its staff. Ongoing discussions about consolidation continue.

Commissioner Hales said this agreement is one of a handful of success stories with the County but more need to be found. He said this was done without much controversy but if it had been in effect 40 years ago Portland would not have ended up with the largest unsewered area in the United States or have so many unpaved streets.

Mayor Katz said Council is committed to reviewing additional opportunities for consolidation.

Disposition: Ordinance No. 171980. (Y-5)

Tentatively grant appeal of Corbett/Terwilliger/Lair Hill Neighborhood Association against Hearings Officer's decision to approve with conditions the application of BRD Restaurants LLC for design and greenway reviews in order to construct a hotel, condominium and spa building at 4640 SW Macadam Avenue; direct Planning Bureau Director to explore further review process (Findings; Previous Agenda 67; 97-00996 DZ)

Discussion: Commissioner Hales said although no formal vote was taken at the last hearing, a straw vote indicated a three to two vote in favor of granting the appeal. Findings have been prepared to which a few corrections are proposed.

Kathryn Beaumont, Senior Deputy City Attorney, reviewed three changes to the findings, all of them non-substantive. She said the options now before Council are to adopt the findings based on the straw vote or to remand the application to the Design Commission to see if a revised design is possible and then hold an evidentiary hearing on the revised design. Either is legally workable although the first option is the cleanest.

Mayor Katz expressed concern about taking a large amount of time and asked if there was any way to expedite this.

Ms. Beaumont said the Planning Bureau indicates it would be possible to expedite a Design Commission review.

Commissioner Francesconi asked about waiving fees.

Ms. Beaumont said that is possible.

Commissioner Kafoury moved to grant the appeal, reverse the Design Commission's decision and remand this back to the Design Commission for an expedited review of a revised design.

Commissioner Francesconi said the developer went beyond what the City required and standing alone this is a good project. However, he does not support the proposal

for three reasons: 1) the scale, mass and height are inadequate; 2) pedestrian access to the Greenway is inadequate; and 3) sunlight, shadow, glare and the effect on Cottonwood Bay are of concern. He said he reviewed the Design Guidelines and noted their emphasis on the enhancement of the Central City as a walkable environment and on preservation of the riverfront as a focal point. The highest priority is to provide livability and open spaces. While the applicant's proposal meets the height and FAR guidelines, the project requires a better relationship to the greenway. He also hopes that a transit plan is addressed.

Commissioner Sten said he wished Council had spent this much time on the Willamette River guidelines when they were brought up in Augusut. With this vote Council is setting standards before it knows where it is going. The City's own regulations allow what the developer has proposed. He will vote aye although he is uncomfortable with the timing as he believes the findings will hold up. The applicant should consider working with the community regarding the river and greenway. He said he would also vote to expedite the new design and hopes that a level of mutual satisfaction can be reached on that one.

Following the vote to adopt the findings granting the appeal, Commissioner Kafoury moved to waive the fee and expedite Design Commission review. Commissioner Francesconi seconded and the motion carried. (Y-5)

Disposition: Findings Adopted (Y-3; N-2, Commissioners Hales and Sten); waive fees and expedite new application. (Y-5)
