744 Deny appeal of Charles Schietinger and approve application of Walter Remmers for a zone change and variance, with conditions, at 708 and 821 SW Maplecrest Court (Findings; 7952 and 7953)

Cay Kershner, Clerk, said on April 18, Council tentatively voted to approve the zone change and deny the variance based on findings prepared by City Attorney Kathryn Imperati and that her findings are to be used today in making a final decision.

743 TIME CERTAIN: 2:00 PM - Appeals of Lois Wakelin/Gary Marshel and Richmond Neighborhood Association against approval of the application of Joseph W. Angel for a zone change from R5 to C2 in order to construct a restaurant and parking lot at 1616, 1626, and 1636 SE 39th Avenue (Hearing; 7958)

Mayor Clark outlined the process for testimony and Council discussed carryover dates and procedures if the matter is not concluded today.

Bob Glasscock, Planning Bureau, reviewed the Hearings Officer's decision with conditions and the appellants' issues. He said the code is very specific about the criteria for approval of a zone change and states approval will be granted if the zone change is to the maximum plan designation and adequate services are presently available or can be reasonably made available.

Mr. Glassock said the Hearings Officer had determined that with the condition of a left turn refuge, services would be adequate and that nuisance impacts such as noise, lights and litter could be addressed by the additional conditions and compliance standards. The C2 zone designation is in compliance with the Comprehensive Plan approved ten years ago. Doug McCallum, Traffic Engineer in Bureau of Traffic Mangement, said many of the issues raised by the appellants were best addressed by the applicant's traffic consultant.

Ky Holland, Richmond Neighborhood Association and Inner Southeast Coalition Chair, said they are challenging the Hearings Officer's decision based on the issue of adequacy of services. He said traffic on the street is already at capacity and appellants do not believe added turning movements and ingress and outgress of traffic should be put into the middle of this congestion. He said they have requested a small scale study to reevaluate this area.

Mr. Holland said placing a fast food restaurant in the neighborhood will result in impacts on traffic and noise that cannot be mitigated. He said the Comprehensive Plan is not a guarantee of zone changes but open for updating and that the neighborhood needs to be protected from the irreparable damage this restaurant will cause.

Pat Barton, Richmond Neighborhood Association, disputed the results of applicant's traffic studies and said the neighborhood had arrived at very different results with slight changes in the data input. He said their studies show the road system is at overcapacity now and the level of service is inadequate. He showed a video of traffic at 39th and SE Hawthorne.

Robert Keech, traffic engineer, said the neighborhood's analysis raised legitimate concerns about the impact of the Burger King facility, especially the drive-through window, on traffic congestion and safety.

David Crow, Richmond Neighborhood Association Board Member and member of the American Planning Association, said the applicant's traffic study had not correctly addressed access or future traffic impacts and that the impact during peak hours would be severe.

Mr. Crow said this proposal does not meet public facilities and services requirements for zone changes and would result in objectionable impacts in violations of the C2 zone. He outlined issues he believes the Hearings Officer failed to adequately address including policing and gang activity, buffering, and the adverse impacts that noise, garbage disposal, lights, and odors would have on the neighborhood. He said this facility does not promote neighborhood liveability and introduces an auto-oriented business into an area which should be pedestrian-oriented.

Mark McKenney, 1625 SE 40th, said this facility will decrease livability to unacceptable levels. He cited concerns about noise, lights and traffic and said the neighborhood is 100 percent against the Burger King because of where it is located.

James Strenz, Mt. Tabor Neighborhood Association, said his neighborhood was particularly worried about the traffic impact on 60th Avenue.

Barbara Rommel, Laurelhurst Neighborhood Association, said her group has twice voted to request Council to deny the zone change because of the adverse impact on traffic.

Pat Anuschat, South Tabor Neighborhood Chair, said her neighborhood objects, not to Burger King, but to a traffic-oriented business that will add to the problems on the street.

Patrick Smith, Sunnyside Neighborhood Association, said the Hawthorne area is in the middle of a neighborhood revitalization and that this facility does not fit the character of the neighborhood. He said they have requested a change back to residential as part of the zoning code rewrite.

Ed Sullivan, attorney for appellants Gary Marshel and Lois Wakelin, said his clients were concerned with the conditions of approval requested by the staff relating to traffic and noise. He outlined a number of conditions his clients have requested to mitigate traffic and noise problems, including elimination of the drive-through window and a request for a public site plan review by a sound engineer.

Because of new information introduced today, Mr. Sullivan requested a setover of seven days to review the new material.

Robert Bernstein, Traffic Engineer, said he reviewed the research presented and found that this proposed use is not consistent with the arterial streets classifiction because of its disruption of the traffic flow. He said the traffic analysis needs to be extended to cover the issue of congestion in the parking lot itself and its effect on 39th Avenue traffic and that the site layout also needs to be looked at again.

Albert Duble, Accoustical Engineer, said he conducted an acoustical study of the site plan and a 24-hour measurement. He said the six-foot masonry wall is grossly inadequate and will do virtually nothing to abate the noise.

Stephen Janik, Attorney for applicant Joe Angel, also requested a holdover in order to respond to new material. He asked Council to look dispassionately at the applicable legal standards in the Code and noted that the Planning staff and Hearings Officer had granted the zone change after six hours of testimony. He said they should be guided by the Comprehensive Plan commercial designation established ten years ago and subsequent decisions made since that time. He said 39th Avenue is an auto-oriented area and is classified as a major city street, a designation reserved for streets carrying the highest volumes of traffic.

Mr. Janik cited the Code which says if conditions are met, the zone change will, not may, be granted and the City has no right to apply any other standards. He said there are two standards to be met: 1) is the rezoning to the maximum intensity of Comprehensive Plan designation; 2) Are services adequate to support zoning change? The answer to the first question is yes and with respect to the second, traffic is the only real issue. He said Mr. Kittelson, applicant's traffic expert, and the City experts agree that it will be adequate, that the left turn refuge will work, and that there will be very little the impact on neighborhood streets. He said applicant agrees to the Hearings Officer's condition providing a left turn refuge even though their position is that it is not essential.

Wayne Kittelson, Traffic Engineer, said his studies show that adequate transportation services are available in the area for the proposed use. He said with the Burger King in place and with some relatively minor adjustments they can make the 39th & Hawthorne intersection operate substantially better than it does today.

Mr. Kittelson said there will be no significant traffic safety problems and the site will have negligible effects on neighboring streets. He showed slides and a video to support these findings and described the field studies that formed the basis for their conclusions.

Mr. Janik rebutted testimony from witnesses about traffic and noise impacts and said that the generalized Comprehensive Plan policies they cite do not apply to a site specific rezoning to bring properties into conformance with the Plan. He said the standard in City Code 33.42.030(a) prohibiting objectionable uses such as noise and lights can not be applied here unless the use is way beyond what is normally allowed.

Joseph Angel, applicant, objected to allegations that he had received special treatment because he was a member of the Planning Commission. He said he acquired the 39th Avenue property based on his reliance on the Comprehensive Plan C2 designation. He said they tried to address the issues raised by the Richmond Neighborhood Association but to no avail though other neighborhoods have found the issues less cut and dried. £99

Council agreed to continue the testimony to 2:00 p.m. Time Certain, May 10 and agreed that those persons who had signed up to testify at today's hearing would be allowed to testify then.

Bob Keech, Traffic Engineer, rebutted Mr. Kittelson's testimony, stating that it did not deal with the issue of spillback and that use of the drive-through window was still understated and could lead to serious safety problems.

Gail Preston, Chair of the Land Use Committee for Richmond Neighborhood Association, asked why, if the Code criteria is the only thing to be considered, the Planning staff in its report had addressed Comprehensive Plan goals and policies.

Commissioner Lindberg asked for a City Attorney opinion as to what criteria Council can use, especially regarding other goals and policies, to make its decision.

City Attorney Pete Kasting said he would prepare a written opinion for Council.

Council determined that at the May 10 hearing, in addition to allowing time for public testimony, ten minutes will be alloted to each of the two appellants and twenty minutes to the applicant to rebut and respond to new information.

Council recessed at 5:30 p.m.

The first five-percent reserve provides funds to cover single-year emergencies while the second five-percent creates a counter-cyclical reserve fund to allow for continuing services during a recession.

Ms. Peterson said the policy can assist the City in labor relations by clearly establishing the City's intention to maintain a healthy reserve in order to weather periods of economic downturn.

Mr. Grewe said the City Attorney advised amending the resolution to require that a verbatim transcript of today's testimony be attached as an exhibit to provide a permanent record of Council's resolve.

Commissioner Koch moved to approve the amendment. On a second by Commissioner Lindberg, the motion carried (Y-5).
