Discussion: Michael Morrissey, 2404 NE 47th, said this will help solve some of their neighborhood traffic problems.

David Cook, 2772 NE Wiberg Lane, said they have worked on this since September of 1988 and feel it will create a more livable neighborhood.

Commissioner Blumenauer said this is a hidden success story for the traffic management program and represents an incredible investment by neighbors and staff in making this project a success.

Leslie Goldsmith, SMILE Neighborhood Association Board member, said one important use for the building will be to store and display Sellwood historical documents.

Catherine Sohm, 7212 SE 17th Avenue, said a strong community effort can be expected for the program they hope to establish at the fire station.

Commissioner Bogle moved to remove the emergency clause. On second by Commissioner Lindberg, the motion carried. (Y-3)

Commissioner Blumenauer asked for Council direction as to whether the loan repayments are to go to the General Fund or to the Facilities Services Fund. He said he would like to see the Office of Finance and Administration and General Services reach agreement on this so Council can deal with it next week.

David Kish, Director of the Bureau of General Services, said the intent was to put the money back into the Facilities Services Fund for subsequent repairs and maintenance on other facilities that they still lease for \$1.00 a year.

Discussion: Commissioner Bogle moved to remove the emergency clause. On second by Commissioner Lindberg, the motion carried. (Y-3) Bob McHugh, Sakrete President, said utilization of this property will help save twelve to fifteen jobs for City residents and create an expanded tax base.

# WEDNESDAY, 2:00 PM, MAY 16, 1990

837 TIME CERTAIN: 2:00 PM - Appeals of Donald & Mary Gilbertson and Adele Kaptur against decision of the Hearings Officer to approve a conditional use to build a parking lot in Columbia Park at 7701 N. Chautauqua Blvd. (Hearing; CU 3-90)

Discussion: Bob Glasscock, Planning Staff, described the project and reviewed the Hearings Officer's decision to grant approval, with conditions, of a 31-space lot adjacent to the Columbia Park pool. He said this proposal came from the Bureau of Parks and was identified as a needed project by the Parks Future Plan to provide safe lighted access to the pool and enhance accessibility for handicapped and elderly users.

Mr. Glasscock said its design and the conditions of the approval will limit the impacts on the park and on the neighborhood. The appellants, he said, feel that the project is not needed, is incompatible with the natural beauty of the park and detrimental to property values.

Mary Gilbertson, appellant, 7664 N. Chautauqua Blvd., said this lot could easily become a trouble spot for gang and other uninvited activities. She said when Dishman Pool is completed the pool clientele will go there and Columbia will be left with an eyesore for years to come. She asked that the money be alloted instead to better lighting, walkways and other improvements.

Adele Kaptur, appellant, 6841 N. Newcastle, said this is an unwise project that will have a destructive impact on the park and damage its natural beauty just for the sake of a few users. She said the Hearings Officer's report had many discrepancies and deficiencies.

Jim Figurski, Parks Bureau, said the proposal will contribute to the safety and security of park users, especially the disabled, and is the result of an extended period of public participation and support. The lot will be well lighted and secured with locking gates during non-pool operating hours to control access.

Mr. Figurski said the lot had been carefully sited to have the least negative impact and that needed improvements to the lighting system will be done separately as part of the lights levy.

Commissioner Bogle queried Mr. Figurski about participation of the immediate neighborhood in the process, access from the street, and the number of handicapped spaces.

Mr. Figurski described the public participation process, cited the safety advantages of a drop-off zone and said a study is to be done to determine how many spaces will be reserved for the handicapped but that it will be more than the minimum of two that are required.

Opponents said the lot is unneccesary and objected to cutting trees and other negative impacts they believe the lot will have on the park. They said it will create problems with littering and noise and attract gangs and drug dealers. They asked for additional lighting to increase security. Many said they had only recently heard of the proposal.

Winchell John Zell, 4640 NE 36th Kim Lathrop, 1319 SE 36th Fred Eckhardt, 35 NE Lombard Supporters said the pool is used by people from all over the area and the parking lot is badly needed to provide safe and secure access for users, particularly the elderly and handicapped.

Appeal of Chris Harris against approval of the application of Greenlick, Pope & Werner for a zone change from R2O to R1O, and a 12-lot subdivision with variances and solar adjustment, located between SW 31st and 27th, Palatine and Stephenson (Hearing; 7967/S 46-89)

Discussion: Miriam Hecht, Planning Bureau, reviewed staff reports and the Hearings Officer's decision.

Appellants Chris and Debbie Harris said there should be a street connection through to SW 31st and objected to the way the lots will be accessed and the reduction in street width allowed by the Hearings Officer.

John Brosy, David Evans & Associates, representing the applicant, said the applicant felt blindsided by the appeal as none of appellant's prior comments had to do with the location of the driveway. He said Mr. Harris' alternatives, to build a roadway at the bottom of the property or a brick wall the length of the property, were unacceptable. Mr. Brosy urged Council to support the Hearings Officer's decision.

Mitch Greenlick, applicant, said Mr. Harris' appeal was frivolous and that, unlike what had occurred on the adjoining subdivision, they planned to keep as many trees as possible on the three lots they plan to build on in Phase 1.

Frank Harris, brother of Chris Harris, asked why applicants had not been required to seek a variance for the road since an exception was granted because of the topography.

Ron Gephart, 11313 SW 33rd, said he was concerned about who would pay for construction of Palatine Road from 35th down to 31st.

Clyde Pope, 11535 SW 33rd, applicant, said this is a modest development of high quality and will not be detrimental to adjoining property owners.

Fedor Manka, 3115 SW Stephenson, developer of twenty-three lots adjacent to the subdivision said he supports the development but opposes the access and asked for a buffer between his development and the one under appeal today.

Commissioner Blumenauer asked that someone from Transportation talk to Mr. Gephart about the City's street improvement policy.

Commissioner Bogle asked appellants and applicants if there was any hope of compromise.

Mr. Pope said not after fifteen years.

Commissioner Blumenauer announced that the public discussion was ended and the matter would be continued to Thursday May 23, 1990 to allow Mayor Clark and Commissioner Koch to review today's testimony before a vote was taken.

Transmit appeal of denial of Secondhand Dealer permit for Robert B. Miles, Jr., dba Thumbtacks to Cadillacs, 5016

NE Martin Luther King Boulevard; recommend denial (Report)

Discussion: Henry Emrich, License Bureau, said granting this permit will aggravate already severe problems in this location.

Lt. Pat Nelson, Police Bureau, said the Police Bureau is adamently opposed to having any secondhand store at this location, no matter who is running it.

Robert Miles, appellant, said that when he took over as manager of Dave's Shop he had cleaned up that operation and cured every one of the problems associated with it. He said he has a history that shows he can make this operation okay also. Mr. Miles said the neighborhood association refused to work with him and that another secondhand shop is being allowed to operate even closer to the area known as "Crack Alley."

Gary McGrew, License Bureau, said Mr. Miles' association with Echols Ford and David Grigonis leads the License Bureau to believe there would be the same kind of problems with Mr. Miles' operation as there have been with the others.

Commissioners stated their support of staff and Police Bureau recommendations.

Disposition: Appeal denied.
