ORDINANCE NO. 183065

Authorize an Intergovernmental Agreement with Multnomah County Department of Community Justice to conduct general heavy brushing work and provide for payment (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Portland Water Bureau, as part of its operational plan, hires seasonal workers to supplement existing resources to address temporary, fluctuating workloads.
2. The City is interested in, and has objectives, in hiring Portland area adults participating in programs administered through the Multnomah County Department of Community Justice in an effort to assist broader community goals as well as filling the needs of the City.
3. The City has worked successfully with the Multnomah County Department of Community Justice to address City objectives, and has funds approved by Council to further these efforts via this Intergovernmental Agreement.
4. The City needs the brushing work to be completed to provide adequate access in case of a fire. The heavy brushing work is usually conducted best during dry season so we need to maximize the number of months we have to complete the brushing.
5. Funding for this project has been approved for \$40,000 in the FY 2009-10 Budget, and additional funding of \$40,000 per fiscal year will be requested in the FY 2010-11 through FY 2013-14 Budgets.

NOW, THEREFORE, the Council directs:

- a. The Water Bureau Administrator and Auditor are authorized to execute on behalf of the City an Intergovernmental Agreement (IGA) with the Multnomah County Department of Community Justice to conduct general heavy brushing work in an amount not to exceed \$40,000 per fiscal year for five years in a form substantially similar to that attached as Exhibit A.
- b. The Mayor and Auditor are hereby authorized to draw and deliver checks chargeable to the Water Fund Account 529000, WAAD00005 when demand is presented and approved by the proper authorities. The Portland Water Bureau intends to request up to \$40,000 per fiscal year for the Intergovernmental Agreement through FY 2013-14.




